Planning approves Moderna security Space Center parking request on hold

The Norwood Planning Board met on June 26 in a hybrid format at the Norwood Senior Center and discussed two large projects.

First up, the Board voted to approve Moderna's plan for security around its facility at the old Polaroid Factory, on the border with Westwood just off of Route 1A. The plan calls for new gates, which Moderna representative David Mackwell said will replace the cars currently blocking the way into the campus at Moderna Way.

The Town recently approved a request to transfer the roads around the campus from public to private ownership so it could restrict access.

Mackwell said truck traffic will be restricted to the northern entrance of the site and added that Moderna will repaint the parking lot as well so trucks will be able to enter and not interfere with any cars or pedestrians. He said the loss of parking was the main reason for Moderna's request, as they had a different number in their original application that was previously approved.

"The other thing we're doing here is the site is going to get fitted with security cameras and call boxes for employees throughout the campus," he said.

The main entrance to the campus will be at Gate H, which will be at the northernmost area of the site, shown on Google Maps as MTC-East Building 400. There will be guard checks for employees and delivery trucks and at the parking lots on the north side of the site.

Mackwell also said they have suggested improvements at Gate A, which is sited basically right at the main building for the facility on Moderna Way, halfway between Route 1A and the One Upland residential building. He said right now there is only an automatic gate that employees can open with a key card, but that Moderna

The Norwood Conservation Commission (ConCom) met on Wednesday, June 28 and signed off on proposed repairs to the Ellis Pond Dam, adjacent to Route 1A near Endicott Street.

Senior Project Engineer of Pare Corp. David Caouette presented the plan including replacement of insulation to the center gate, reseating of the center grate seal, jutting and realigning of the toe gate seal, and vegetation management.

Caouette said the project was initiated because a recent inspection found several problems impeding the dam's use. The conditions were found to be fair-to-satisfactory on a scale of good, satisfactory, fair and poor.

One of the low-level outlets for the dam was found to be in particular need of repairs, mainly because is hasn't been used in quite a while.

"We did a dive inspection back in 2022, and found some sedimentation in the intake pipes. We want to have a diver on site and work with the (Norwood Department of Public Works) DPW just to make sure that in the event it was opened and couldn't be shut we have a contingency plan in place," he said. "That's on the list

said that a condition of approval for the plan should be the continued coordination with the Norwood Fire Department (NFD) and the Norwood Police Department (NPD) to provide a plan satisfactory to both agencies.

"So as to provide emergency access and signage," she said. "Police and Fire have had some questions as to access to the site and other security issues and so this would just be making sure that there is continued cooperation as an explicit condition of approval."

Conservation Agent and Assistant Town Planner Holly Jones also discussed the planting plan that was a condition of approval of the Conservation Commission. She said it basically required all native plants be used.

"We did receive a planting plan, but there were a small number of non-native species on it and we're waiting for a revised version of the plan," she said.

Dixon recommended that the receipt of a revised planting plan also be made a condition of approval. The Board voted unanimously to approve the site plan with all previously mentioned conditions

sue with the plan itself, and everyone in the room seemed assured by the fact the original special permit requires DePree to do a traffic study during the first six months of operation to ensure that parking was reasonably available and traffic was not unduly high. Planning Board members and Hern both commented that they have not seen the parking lot at the Space Center near capacity except for special events, so no one seemed to think this was a likely possibility

The reason for the continuance was because of the neighboring property. Landlord Thomas Kraus owns 71 Morse St., directly adjacent to the Space Center on the west side. The new 17 spaces (and proposed parking for more 48 spaces if the traffic study finds they need more) that would accommodate the additional dining seats (though not necessarily dedicated spaces for the food court) would be on the western side of the Space Center's buildings, accessibly by Short Street. Kraus' property would be in direct line-of-sight for any headlights of vehicles pulling into the parking lot approaching from the east; basically anyone coming from Pleasant Street or Route 1. He asked for screening from the light so as to not create a detriment to the quality of life of his tenants. The Board discussed it with DePree and after about an hour of going back and forth, it was agreed that DePree would work with Kraus to figure out a solution and bring it to the Board. DePree said he didn't want to commit to any one plan now because if it was found to be improper or not possible, he said then the Board might find him out of compliance.

Food Forest needs volunteers moving into summer

The Mylod Street Food Forest, situated right next to the Norwood Community Garden and the Coakley Middle School, could use a little tender loving care this summer from residents, and the Conservation Commission is asking for volunteers.

Every gardener probably already knows the routine, but for those uninitiated, weeds are the growing problem in the summer.

However, Conservation Agent and Assistant Town Planner Holly Jones said that it's not all bad. Some of the plants growing now will be, at least peripherally, beneficial to the forest.

having quite a lot of milkweeds grow very well and we're excited to leave those be and provide butterfly food," she said.

However, with beneficial plants come imitators looking to take advantage of their looks, and that's exactly what's happening now. Jones said they want to attract butterflies, in part because they look nice but also because they can help pollinate the plants, but the imitators aren't helping.

"We have a plant called black swallow-wort, which is

ally related to milkweeds, but it's not a plant that can be used by monarch butterflies," she said. "They're finding the plant is actually a problem for monarch butterflies, because they lay their eggs on the swallowwort and the newly-hatched pupae can't eat it and die. So we don't like the swallow-wort, partly because it's taking over and partly it's confusing our native butterflies."

The objective also includes removing a good deal of poison ivy, but not by hand so if you're looking to come lend a hand, Jones advised that residents should come prepared to protect themselves.

"I would definitely say bring long pants and closetoed shoes," she said. "There "Around the trees, we're is a good amount of poison ivy, and while we won't be pulling it up it would be a good idea to stay protected from that."

> Jones said there will be some gloves available for residents to grab, but advised that one size does not necessarily fit all and that residents should, if they can, bring their own to ensure comfort while weeding.

"I don't think we'll be pulling up anything that looks like a bush, shrub or fern," Jones said.

She said that while one or two shrubs were lost through the winter, no trees were damaged or lost. They doubled up on nitrogen-fixing plants, and while they lost three of these helper shrubs, each tree that lost one had another to help fix the nitrogen in the soil and promote growth.


"Another big accomplishment is we installed irrigation this spring, though we haven't had to use it yet because it's been so wet outside," she said. "But that means the Juneberries, that would normally be harvestable right now, got a fungus due to the wet weather and were not able to be harvested."

is that many of the orchard's

stone fruit trees are starting to bud. Much of the stone fruit, peaches, plumbs etc., in Massachusetts were damaged by the warm winter followed by the deep freeze back in February. She said many trees started to bud and then those buds were killed off by the freeze. In Norwood, many of the peach trees are at least now starting their budding cycle.

"We've got some peaches and cherries coming along. Somehow we managed to not be as severely impacted by the problem that the rest of the state is seeing, which is cool," she said. "We've also got quite a few good looking apples and one plumb tree that are coming along too."



GOOD DEEDS: GETTING LAWS PASSED AND YOU

William P. O'Donnell Norfolk County Register of Deeds

There are a number of documents recorded at the Norfolk Registry of Deeds that pertain to the four United States Presidents born in Norfolk County. One of those Presidents, John Adams, stated, "We are a government of laws, and not of men."

In my tenure as Norfolk Register of Deeds, I have gotten to experience firsthand the making of laws. Laws govern our daily lives and have significant impacts. Not that long ago, the Homestead Protection for your home was \$300,000.00. The legislative process here in Massachusetts increased the Homestead Protection you can put on your home to \$500,000.00. This change in a law benefited each of you as a consumer who owns a house or condominium as your principal residence.

A Mortgage Discharge Bill was passed into law, giving you, as real estate borrowers, assistance in getting your mortgage discharge document. This is impactful, as a mortgage discharge once recorded at the Registry of Deeds tells the world that your loan has been paid off. The Community Preservation Act, which so many of our local communities have implemented, started as an idea in a bill that later became state law here in Massachusetts.

How do bills become laws?

A bill becomes a law once it has been passed by the State Legislature and signed by the Governor. Once a bill is introduced in either the State House of Representatives or the State Senate, it goes through a series of committee hearings before it is voted on. Members of the committee can ask questions, suggest changes, and vote on whether or not the bill should be sent to the full House or Senate for consideration. Understanding the legislative process can empower you to engage in advocacy and allow you to see how your elected officials are or are not working on issues that matter to you. Committee hearings are an essential part of the legislative process, as they provide an opportunity for lawmakers to fully understand the potential impact of a bill and make informed decisions. As Register of Deeds I was very involved in getting a law passed that paved the way for registered land documents to be remotely submitted electronically via the internet for recording at the Registry of Deeds. On January 11, 2017, a filed bill, House Bill 3862, An Act Modernizing the Registries of Deeds, became Chapter 404 of the Acts of 2016. What went into the passing of this law? A draft of the legislation, accompanied by a fact sheet, was sent to each one of the 200 members of the State Legislature.

Calls and emails were made in order to get this bill passed into law. When the bill had its hearing before the Joint Committee on Judiciary, I along with other Registers appeared before the committee to provide testimony.

The effect of this bill was to pave the way for electronic recording of Land Court documents. What is now seen as commonplace today only came about because House Bill 3862 received a favorable vote from the Judiciary Committee. Once this favorable vote occurred, the bill is sent to the House Committee on Ways and Means which reviews every bill for its fiscal impact. From there this piece of legislation, like all bills that become law, went to the House Committee on Bills in the Third Reading for their legal review and approval.

House Bill 3862 once receiving approval from all these committees, went to the full floor of the State House of Representatives, where it received a favorable vote. In the State Senate, a similar process occurred, with the legislation getting favorable reviews and votes from that branch's Ways and Means as well as Third Reading Committees before hitting the Senate Floor for a favorable vote.

After clearing both chambers, the legislation was sent to the Governor's Office, where the executive staff did their own fiscal and legal analysis. The Governor signed this bill into law becoming effective 90 days later. On that day, the Norfolk County Registry of Deeds became the first Registry of Deeds in Masmittee as House Bill #1411.

If enacted, this legislation will eliminate the possibility that a homeowner may not know who the holder of their mortgage is because a mortgage assignment was not recorded at the Registry of Deeds. This legislation would make assignments of residential mortgages more transparent for the consumer. You, as a borrower, could just look up this information from your home computer via the internet on the Registry's land records website at www.norfolkdeeds.org or call the Norfolk Registry's Customer Service Center.

Also up for consideration is a bill requiring automatic external defibrillators in Norfolk County public buildings. Representative Denise Garlick filed legislation in the Massachusetts House of Representatives. This bill was given House Docket #1842 and referred to the Joint Committee on Municipalities and Regional Government as House Bill #2051.

I was very proud back in 2010 to install and maintain automatic external defibrillators (AED) on all three floors of the Norfolk County Registry of Deeds building. The Registry of Deeds also pays for the training of staff on the AED, which is a lightweight portable device that delivers an electric shock through the chest to the heart. The American Red Cross states that there are better survival rates and outcomes if an AED is used on a person experiencing sudden cardiac arrest in a timely manner. The American Red Cross has estimated that some 50,000 lives could be saved with improved training and access to an AED. Representative Denise Garlick wants to use Norfolk County as a pilot program. The more locations for the AED, increases all our chances for a better health result. The difference between life and death may be the availability of a functioning AED unit. You have learned about the law-making process. You have read about bills that have become laws and some bills that are being considered to become law. Maybe some issues or matters you feel strongly about can be put into place by passing a law, as we are a society as well as a government of laws.

About Income Tax on **Social Security Benefits**

Dear Rusty: I retired froDear Rusty: I just started receiving my Social Security in February of 2023. I am also working part time at a company 24 hours a week. My question is... I feel like I missed something when I signed up for Social Security because they are not taking any taxes out. What did I miss? How do I go about fixing it so I don't get hit at the end of the year? They are taking taxes out of my paycheck now, do they still take it out of my Social Security because I am working? Please help if I am not doing something right.

Dear Conscientious: Unfortunately, when the Social Administration Security processes your application for benefits, they don't usually inform you that your Social Security benefits may become part of your taxable income. I expect that's because your benefits only "may" become taxable – they do not definitely become taxable, because Social Security benefits are taxed only if you exceed a certain income threshold.

The thresholds at which Social Security benefits become part of your taxable income are different depending on your income tax filing status - those who file as an individual have a different threshold from those who file as "married - filing jointly." And to further complicate matters there is more than one threshold for both individuals and joint filers. Here's how it works:

If you file your income tax as an individual and your "combined income" from all sources is more than \$25,000, then 50% of the Social Security benefits you received during the tax year becomes part of your overall taxable income at your particular IRS tax rate. But if your combined income as an individual tax filer is more than \$34,000 then up to 85% of the SS benefits you received during the tax becomes part of your overall taxable income.

If your income tax filing status is "married - filing

"MAGI." Your MAGI is your Adjusted Gross Income on your tax return, plus 50% of the Social Security benefits you received during the tax year, plus any non-taxable interest or untaxed foreign income you had (note that withdrawals from a Roth IRA are not included). If your "MAGI" exceeds the above thresholds, some of your Social Security benefits are taxable; if you are under the first threshold for your IRS filing status they are not.

Social Security doesn't automatically withhold taxes from your monthly benefits, and the FICA tax being withheld from your earnings are not used for that purpose. Everyone who works and earns must pay SS tax on their earnings, which are mandatory contributions supporting the federal Social Security program. But that FICA payroll tax has nothing to do with income tax on your Social Security benefits. If you are working 24 hours per week and also collecting Social Security benefits, you will likely exceed the threshold for your tax filing status, which means that at least some of your 2023 benefits will become taxable. That could, as you suspect, result in a surprise "hit" when you file next year's income tax return. Nevertheless, fixing this is quite easy:

Download IRS form W-4V from the IRS website here: www.irs.gov/pub/irs-pdf/ fw4v.pdf. You will be able to choose the percentage of your Social Security benefits you wish to have withheld for Complete the form and mail it to your local Social Security office (get the mailing address here: www.ssa.gov/locator). Social Security will then start withholding income tax from your monthly Social Security benefit payment, which will mitigate any additional tax due when you file your 2023 tax return next year.



of work to do."

Caouette said the center gate on the low-level spillway has also been found to have problems. They think the center seal along the bottom of the gate is stuck between the gate frame and the gate, causing at least friction, and could later get stuck.

"Which is contributing to the difficulty of operating the gate," he said. "So what we're proposing is to attach a steel plate to the center of the spillway that we can use to stop water flowing to that center bay. We can lift the gate, remove the seal, put a new seal in there and restore gate operation."

Caouette said there is some sediment buildup at the bottom of the gate, and they would also want to remove that as well. All the work on the gate would be completed in dry conditions.

"During that time, water will still be able to flow to the downstream of this channel; there are two gates on either side of this and so water will maintain base flow into the downstream channel past the base gate," he said.

There is also what is called a toe drain at the bottom of the dam which is installed to collect and convey seepage that goes through the embankment. It is currently misaligned and not doing its job.

"At the discharge end of the toe drain, which discharges into the brook, there's discontinuity so it's not allowing flow to come out to a visible location and discharge water behind the structure," he said. "You can't really then quantify how much seepage there is. So in terms of dam safety, we want to be able to quantify the seepage to know how much water is going through the dam. We'd have to remove the riprap, put a coupling on the existing pipe and put the riprap back into place."

Also in the report, on the other side of the dam is an emergency spillway. You might have noticed it driving by, looking like a chess board bordered by greenery. The emergency spillway uses checkered stone blocks that are reinforced by metal wire. and cut the wires," he said.

"Or, if they want to maintain the wires, they can go in and dig out a small channel between the blocks and encase them in grout."

Caouette said the wires were originally damaged, likely by a lawnmower.

"There's wire now sticking up out of the blocks, and several of them were severed from what looks like lawn mowing equipment which probably struck it and did a fair amount of damage to the blades of the mowers," he said.

Norwood Acting Conservation Agent and Assistant Town Planner Holly Jones said she recommended the ConCom approve most of the recommendations from Pare. She said, however the emergency spillway repairs are already underway by the DPW, and said the DPW would undertake the toe drain repairs as well.

"So that can be just adjusted in place without any additional impact to the resource areas in the stream," she said.

She also recommended not to move forward with the installation of what's called a Vnotch weir that Caouette said was an optional choice in Pare's estimation.

"Otherwise I see these repairs as largely maintenance issues," she said.

Jones said the funds for this project are allocated in the Capital Plan that will go before Town Meeting in the fall. She said DPW Director Mark Ryan and the regular dam operator Ryan Manning, have both signed off on the proposed repairs. The non-DPW work would be undertaken by a contractor after a bidding process. The ConCom voted unanimously to issue a determination of non-applicability to the project, allowing it to move forward to the next step.

program at the library."

Lane said the department had the grant for two years and is now complete. The second grant is new from Beth Israel Deaconess Medical Center in the beginning of last week. Needham. The grant is for \$30,000 a year for the next three years to help Norwood residents, age 55 and older, get to medical appointments.

Next, Regional Tobacco Program Coordinator Rotem Aloni gave her report. She said over the past month or so they had several sting operations where they used a youth buyer to go into a store to try to buy tobacco products. She said she was happy to report only one violation.

"That was on Monday, June 19, at Mr. Frank's Food Mart," she said. "We had a youth buyer go into the establishment and the youth was able to buy cigarettes without being carded. As a result, they have been sent a ceaseand-desist letter that notifies them of a \$1,000 fine and a three-day suspension of their

(tobacco sales) permit. They have seven days to request a hearing before the Board to contest this."

The permit was suspended at Aloni said, currently, they only have one youth buyer working with the department, but added they are looking to add more in the future.

"It makes it easier logistically if one person's not available another may be," she said.

Member Carolyn Riccardi said she believes this was Mr. Frank's first violation, and Aloni said she believed it was and the employee involved was new and inexperienced.

"It's all about education," Aloni said.

"They're very reputable and they just made a mistake," Riccardi said.

Norwood Public Health Nurse Diana Hillery also came in to give her regular report. Riccardi said she's seeing anecdotal evidence of more and more COVID-19 infections in

Norwood.

"I am seeing more and more people masked and when I ask them, they tell me they just got over COVID," she said.

"It's not going away," said Hillery.

Chair Kathleen Bishop pointed out that Moderna is seeking approval from the FDA for its next COVID-19 vaccine that will be prepared by fall. Experts are saying may see a resurgence of the disease around that time.

Hillery said they're moving to provide annual COVID shots along with the flu vaccine every fall.

"Your chances of getting people to take two shots at once are slim-to-none I think," said member Joan Jacobs.

"Hopefully come the fall everybody will be boosted up with both shots and we won't have to worry as much," said Hillery.

The Board will meet next on Tuesday, Sept. 12 at 10 a.m. at a location to be determined.


