# **ConCom approves Cooper Park plan**

The Norwood Conservation Commission (ConCom) met on July 12 and voted to approve the Bernie Cooper Park plan on the Saints Street Lot at 84 Morse St./0 St. Joseph's Avenue.

Horsely Whitten representatives Hannah Carlson and Brian Kuchar presented the plan, which is an updated version of the one presented during community meetings in 2021.

Kuchar said the site is what they refer to as a disturbed vegetated site, in that there's a lot of vegetation and it has a fair amount of buried pavement under much of the greenery. He said they have almost an acre of pavement to deal with.

"It was used as a parking lot at one time for use by the surrounding area and the factory across the river," he said.

The area is also inundated with invasive species, which the park plan is looking to control.

The four main goals of the park development are to expand on the trails and informal paths currently in use, provide connectivity to the Elliot Park, enhance the ecological value of the property (invasive control and replacement) and to control the stormwater from the Saint Streets.

"It runs through the parcel uncontrolled; the parcel actually does a pretty good job of infiltrating that stormwater, but we're looking to collect, capture and treat it prior to that discharge and infiltration with some green infrastructure practices as well," he said.

Carlson said the park's de-

sign is the result of outreach meetings with residents and officials.

"You'll see the plan we have now is pretty similar to what we landed on in the past," she said. "You'll see some things are in slightly different locations, but really the core of what we heard from people during that process is what we still have."

Carlson said despite the large number of invasive species at the site, residents indicated they wanted to keep a lot of greenery and environment. She said the plan incorporates this feeling, as it keeps some of the larger invasive species where they are in order to maintain the habitat they've been providing. She said long-term maintenance could reduce the reproduction of these kinds of

### **MSBC to move** community comment meetings

The Norwood Middle School Building Committee (MSBC) met on July 10 and discussed the community comment meetings held on Fridays over the past couple of weeks and their sparse attendance.

The purpose of the meetings was to allow residents to come and express their thoughts and issues regarding the construction process now taking place at the Philip Coakley Middle School in South Norwood. Members of the project Owners Project Management (OPM) team said they were thinking it might be better to incorporate those meetings into the regular MSBC meetings, usually held once a month, on a Monday.

"It's not getting super or sometimes any attendance on Friday mornings and it is taking an hour or so of time for the staff to come over and do it," said Vertex representative James Boudreau.

Boureau said he'd want to have the MSBC meetings in a hybrid format so that more community members could have an opportunity to attend.

"It's obviously more convenient in terms of timing for people," he said. "The purpose of that meeting is to hear about any issues the project is causing so we can address them before they become really big issues. It's something we wanted to bring up here to see if we would discontinue that meeting and give people the chance as part of a public comment session at the beginning of these meetings (MSBC)."

School Committee representative Teresa Stewart said she had previously shared that there were residents who wanted to come to the comment meetings, but since they were so early and in-person only, those people could not attend. She added that the School Committee already has a policy for public comment that could be easily duplicated by the MSBC.

The MSBC voted unanimously to discontinue the community meetings in favor of a hybrid option at MSBC meetings. However, the community meeting scheduled on Aug. 4 at 10 a.m. will still take place.

On a related note, the Board is looking to hold its meetings earlier in the day to accommodate everyone's schedule. Facilities Department Director Phil Riccardi said it



# **DEATH VALLEY**

Leaving the San Fernando Valley, it was 72 degrees; forecast was a high of 126 in the other valley. Like a toad drawn to a roaring campfire, I hopped in my car. On the way I thought: our vocabulary reflects the very seed of primal experience, the sun paramount. Safety in daytime's light and heat as well as danger in nighttime's darkness and cold inform our earliest attempts at verbal communication. So ingrained are these, that the very words themselves are metaphors. Thus, a hot stock is good, as is a hot ticket and a hot-looking person. If someone's ready, they're hot to trot. We experience the heat of passion, and then romance cools. A cold stare, a cold shoulder, a cold heart. If startled or uneasy, a cold chill runs down your spine. A hot time beats a cool reception. A gaze can melt a woman's heart; beware association with a frigid woman. We have warm memories; we catch a cold.

Up the 5 and east through burgeoning Palmdale, up 14 through Mohave and its army of white, gyrating wind turbines, marching in place and in perfect cadence. Further to Cantil and Ridgecrest where lies detritus dirt backwash, railroad tracks and truck stops, the California not seen in ads. Through Ridgecrest and Trona it's 98 degrees, past Ballarat ghost town it hits 105.

On the way I thought: historically we have the Enlightenment, as well as the Dark Ages. We have sunny dispositions, as well as a dark side. If close to discovery, we're getting warmer, and then the trail runs cold. We have a ray of hope. A burning question requires attention; in its revelation we've seen the light. If unresolved it be-

comes a cold case. People can leave you warm and fuzzy, others need to chill out. We endure icy stares. Some are fired with ambition; hesitation indicates cold feet. We warm to a task. We follow with interest a hot topic; others leave us cold. On a winning streak, we're hot as a pistol. We freeze like a deer in the headlights.

Baked brown earth thrown to jagged, low mountains cradling Death Valley. A sign commemorates Seldom Seen Slim, the areas last resident, who died in 1968. Sign, Death Valley National Park at 11:23 a.m., holding fast at 105 degrees. Inside the park, the glistening tar ribbon climbs. At 4000-foot elevation it dips to 95, at the top of the pass it bottoms at 91. Descending into the shimmering, heat waved, white-clay bowl it rises; at 4000 feet again 95, at Towne Pass' 3000-foot elevation 98, at 2000 feet 104, at 1000 feet 109.

You get black-balled, experience Black Friday, and contract Black Plague. You have liquid assets until they're frozen. You have ice in your veins. You shed light on a problem and give it hell.

I cruise into Death Valley, sipping from a water bottle. The place is desolate, forbidding, roads so little traveled that even today to get stuck is dangerous. Concern is verified at a pullover, where a warning sign relates tales of hikers who have perished. At Stovepipe Wells, elevation 5 feet, the temperature reaches 114. Descending further into the bowl, at 200 feet below sea level it is 116. At noon it is 118, an hour later 120. The landscape is otherworldly; salt flats shimmering under an intense downpour of light, corralled by surrounding high heaps of earth. At 1:30 is experienced the highest temperature of the day, 122 degrees Fahrenheit. I pull over and emerge from my air-conditioned car, the instant sensation that of opening an oven and being rushed by heat. My glasses instantly fog. It engulfs, pressures, and cooks. Re-



positive, safe experiences, cold and dark with negative and dangerous. Thus, we have sports teams named the Calgary Flames and not the Calgary Ice, the Miami Heat and not the Cold, the Tampa Bay Lightning and not the Hail Stones, the Phoenix Suns and not the Moons, the Dallas Stars and not the Black Holes. Pondering ancient experience and its effect on human consciousness, recognized is perhaps our most ingrained metaphor, that of sun-driven spring's blossoming-the dawn of life and an open book-and winters' diminishing light, life's sunset and the conclusion of the story.

Even the sun's position informs etymology. When high we look up to it in safety, when it lowers toward encroaching danger, we look down. Thus, we live the high life and know low-lifes. We look up to those admired and down on those below us. We have Your Royal Highness and her subjects. Thumbs up, thumbs down. We have lofty ambitions and low expectations. We rise to the occasion and stoop to their level. Laws are upheld, though some are beneath our dignity. We have uplifted spirits unless we are downcast. Is there any question why ancients determined Heaven was above, and Hell below?

It's time to leave Death Valley's heat and its suggestive allusions, similes, and metaphors. I drive desert toward Pahrump and its turnoff to Las Vegas. There I will see my

### Liquor license issues abound at Selectmen

The Norwood Board of Selectmen met on July 18 at the Norwood Town Hall and voted on a liquor license transfer and three license applications.

The Board voted to deny three requests for the Town's last allalcohol liquor license. The general consensus was that the three applications either didn't meet the necessary bars of public good and public need and/or the applications were deficient.

The only application the Board expressed some merit toward was from Hometown Arcade at 61 Endicott St. at the Winsmith Mill. Applicant Matt Snow said he, his wife and his business partner wanted to expand offerings at the arcade, which offers classic video games, tabletop sport games, Pinball and console games for a flat rate of \$20.

"We're pursuing the license because we've heard a lot of feedback from guests and community members that this is an offering they'd like us to add," Snow said.

During the Board's review, Selectman Bill Plasko noted several deficiencies in the application, including the lack of detail in the submitted floor plan and the fact that the establishment would not be offering any food. Snow said they have an agreement with a dedicated food truck outside the building, but Plasko said he wasn't sure that would cut it.

He and Town Counsel David DeLuca both concluded that under this arrangement what they would be issuing would be a Tavern License, something they haven't issued in a very long time.

"In recent memory, at least since I've been around," said Plasko.

DeLuca said the Town's restaurant licenses require food, whereas a tavern license would not.

Tipico Salvadoreno 2, at 514 Washington St. also applied for the license. Owners and managers Lidia and Freddy Romero said they wanted to expand offerings for their business. Attorney David Hern represented them during the hearing.

"It's really a family operation and something they're very committed to and I hope you'll be able to look favorably on their application," Hern said.

Prieto Empanada II, at 111 Lenox St. was also applying for the license, and owner Jose Pimentel said he also had requests from guests for alcohol during sporting events and meals.

The issue the Board had with these two applications included that the applications were not in exact order and the size of the establishments – both 1,750 square feet – did not align with other restaurants holding licenses that were larger in sq ft and provided more seating.

"When we look at the list of all-alcohol licenses provided, the three applicants this evening do not seem to be consistent with approvals that we've given in the past," said Selectman Bob Donnelly. "'I'm seeing very much a theme for most of our license holders for an all-alcohol license, which is that they are large restaurants with large seating capacity."

Plasko said he didn't feel these applications met a "sufficient public need or proper use for the licenses for the public good and service to the public with the license as well as possible."

The Board voted unanimously three times to deny each applicant. DeLuca said they could reapply if they so wished later.

In other booze news, the Board voted to accept a beer and wine license transfer from Convenient Food Part to the Norwood Citgo, located at 960 Boston Providence Hwy.

The Board had already voted

once before on the transfer request but was deadlocked at 2-2. Selectmen Chair Matt Lane was not at the prior meeting when the vote was taken. Plasko and Selectman Michael Saad voted to deny the transfer and Selectman Amanda Grow and Donnelly both voted for it. Lane said he was in support of the transfer at Tuesday's meeting because there was, arguably, a need for it in that location and because of the history of the license itself.

Earlier in the year, the original holder of the license obtained it from the Town with the promise of using it, but ended up selling it to Mahendrakumar Patel, the owner of Convenient Food Mart. This garnered discussion among the Board that some license seekers may be purely speculative in their purchase and do not want

### The Norwood Record NFD wants residents prepared

Chief Timothy Bailey and the Norwood Fire Department wish to share guidance on hurricane awareness and preparedness this season. Gov. Maura Healey has proclaimed July 9-15 as Hurricane Preparedness Week in Massachusetts, which recognizes the importance of preparing for the impact of extreme weather.

June 1 marked the official start of the Atlantic Hurricane Season, which runs through Nov. 30. Most hurricanes and tropical storms that impact New England occur during late August and September, and residents are encouraged to prepare early.

Hurricanes can bring many types of wind and water hazards, including storm surges, strong winds and flooding. The Department of Homeland Security and the Federal Emergency Management Agency (FEMA) offer several tips to help residents better prepare for extreme weather should it occur.

Know Your Evacuation Zone: Learn if you live or work in a hurricane evacuation zone. The best action to protect yourself and your family from the flooding and high winds caused by hurricanes is to evacuate when ordered to do so, before those conditions hit your area. Know and follow the directions from local officials for community evacuation and follow posted evacuation routes.

Visit www.mass.gov/ knowyourzone to learn if you live or work in a hurricane evacuation zone. If you live in an area that may flood and may need assistance evacuating, plan with family, neighbors, and friends who may be able to assist, and contact your local public safety officials to make them aware of your needs.

Make an Emergency Plan:

Have an emergency plan for how your family would communicate, evacuate and shelter in place should there be an emergency. An emergency plan should address the specific needs of all of your family members and those you are responsible for.

Steps to making an emergency plan include the following: Discuss the questions below with your family, friends, or household: How will I receive emergency alerts and warnings? What is my shelter plan? What is my evacuation route? What is my family/ household communication plan?

Consider specific needs for everyone in your household, including seniors, children, individuals with access and functional needs, and pets. Dietary needs, medical needs including prescriptions and equipment, disabilities or access and functional needs including devices and equipment, and cultural and religious considerations should all be taken into account when creating an emergency plan. Fill out a Family Emergency Plan.

Practice your plan with your family/household.

Build an Emergency Kit: Build an emergency kit that will sustain your household for 3-5 days without power. A basic emergency supply kit might include the following recommended items: Food and water: Battery-powered or hand-crank radio and a NOAA Weather Radio with tone alert: Flashlight and extra batteries: First aid kit: Whistle (to signal for help): Dust mask (to help filter contaminated air): Soap, hand sanitizer, and disinfecting wipes: Prescription and non-prescription medications: Eyeglasses and contact lens solution: Infant formula, bottles, diapers, and wipes: Important family documents, and cash or traveler's checks: Plastic sheeting and duct tape (to shelter in place): Moist towelettes, garbage bags, and plastic ties (for personal sanitation): Wrench or pliers (to turn off utilities): Manual can opener (for food): Local maps: Cell phone with chargers and a backup battery.

Store items in airtight plastic bags and put your entire disaster supplies kit in one or two easyto-carry containers such as plastic bins or a duffel bag.

Prepare Your Home: You can improve your home's ability to withstand hurricane conditions. Consider cutting weak branches and trees that could fall on your house. Make sure there's nothing that could blow around during the storm and damage your home, and move bikes, lawn furniture, grills, propane tanks and building material inside or under shelter. Keep drains, gutters and downspouts clear of debris. Cover up windows and doors by using storm shutters or pieces of plywood. Secure all doors on your property and find a safe location for your vehicle.

to provide the service the license allows for, but to simply flip it to make a buck.

Regardless, Patel had obtained the beer and wine license by purchase and wanted to use it for Washington Street, but subsequently obtained an all-alcohol license. At that point he was required to sell his beer and wine license or face giving it back to the Town without compensation. Lane said that while the Town wanted more licenses located in South Norwood and Downtown, it felt like they were punishing Patel for not finding a buyer exactly where they wanted one to be. Furthermore, there was the issue of saturation. DeLuca said the definition of saturation of licenses in one area is defined by the local municipal issuing board. Basically, it's up to the Board of Selectmen to determine if an area is getting saturated. The Mobil across the street from

the Citgo already sells beer and wine, and on the other side of Route 1 is Yankee Spirits.

The Board voted 3-2 with Plasko and Saad against – to approve the transfer.

The Board also voted to authorize the Town to continue negotiations with Sunrise Assisted Living and the Town of Sharon for a possible sewer connection. The issue is that Sunrise is looking to put in a new facility on the Norwood/ Sharon Border off of Edgehill Road near Union Street in Norwood. Department of Public Works Director Mark Ryan said this request was much like the 2006 approved Avalon Bay connection between Sharon and Norwood. Ryan said going by how the 2006 deal panned out, the Town is looking at making some good money, around a few million dollars. However, Ryan was quick to point out that this is just an initial estimate and that dollar value could fluctuate significantly during negotiations.

Ryan also said the Town has no obligation to provide this connection and could discontinue negotiations at any point, but noted that benefits, aside from the cash, include improvements to the infrastructure in that area as well.

"This is a dollar value that

might benefit us greatly and there are a couple of other items in there that might help us out financially to improve our infrastructure, but are we in dire need of it? No I don't think so."

The Board voted to authorize continued conversations subject to the Board being able to review and approve the final contract.

Lastly, Selectman Grow said Norwood's legislators are coming to the next meeting, scheduled for July 25, giving Selectmen a chance to directly ask questions of State Rep. John Rogers and State Sen. Michael Rush.

### **Residents urged to avoid Upland Road/1A traffic light construction**

Residents on Route 1A/Upland Road most likely have noticed the growing slowdowns at the entrance to Moderna's facility off of Upland Woods Circle.

Norwood Department of Public Works (DPW) Director Mark Ryan said the construction of the traffic light is being funded by Alexandria Real Estate, which owns the land at the Moderna site bordering Westwood.

"There will definitely be slow traffic going through there,

and so if you have an alternative way to get where you're going, it's probably a good idea," he said. "The evening and morning commutes especially will be slower because of the barriers there."

The light installation is part of an agreement struck with the previous landowner, Campanelli Construction and Development, more than 15 years ago that stipulated if traffic reached a

certain threshold, the light would have to be installed. This was part of a development agreement for other work going on within the industrial park at the time.

"That was part of the permitting process with Campanelli back in the early 2000s," Ryan said. "So Alexandria is now funding that project. It's a state **Upland Traffic**

# **Community Preservation Committee** provides project updates, five-year plan

The Norwood Community Preservation Committee (CPC) met on July 12 and discussed updates to several approved projects as well as how it's looking at the future of Community Preservation Act (CPA) funds.

First up, CPC Coordinator Kristen Phelps said the project at the Balch Lower Elliot Field work is mostly done, but work remaining includes the installation of accessible ramps as per the Americans with Disabilities Act (ADA). She said currently they are looking for a contractor to design and build the project, which is slated to cost about \$70,000. The inclusion of the ramp is the result of community input on a 2020approved plan to rehabilitate the skate park and basketball court. The ramp has been stalled because costs for such work, as with everything else in this post-COVID-19 supply chain world, have gone up considerably.

"The question is can we hire one firm to do it all with \$40,000 for design and whatever the construction is going to be," Phelps said.

Phelps said she, member Joseph Greeley and Depart-

ment of Public Works (DPW) Director Mark Ryan are looking into if they can combine the work to save some money, and will have at least some options for that or, if that turns out not to be feasible, an alternative plan by the next CPC meeting.

In other business, Phelps said the Stearns and Elliot Pocket Park, originally budgeted at the 2022 Annual Town Meeting for \$72,000, is moving along nicely.

"I don't know if you all have been by there but it's getting very close," she said. "It's exciting; the benches are in and they put in so many arborvitaes, and (Conservation Agent) Holly Jones provided a planting plan, as there's a small basin there that they'll be planting in the fall and the center area in the more formal park between the benches."

Phelps also said that a resident with a botany background has come forward to work with Jones to come up with lowmaintenance native plants for the park.

"She's going to be working with Holly to suggest some plants for the site," she said. "So hopefully sometime this fall that will wrap up and it looks like we'll get a little money back from that one. There's about \$18,000 left in that account with about \$7,000 or \$8,000 still needed for planting and other work to do."

As for the future, Phelps said she wants to begin putting together a five-year plan. She is scheduling with several committees connected to CPA's main three funding areas – open space and recreation, housing and historic preservation – to try to get ideas to map out at least some of the CPA's future projects.

"At the last meeting you had asked about doing some sort of questionnaire to go out to the Boards and Commissions just to start getting feedback and thinking long-term," she said, adding she's scheduled to meet with Greeley, who is also the Norwood Trails Advisory Committee Chair, and Norwood Director of Finance Meg LaMay, "just having something in mind, both financially and a projects-inthe-pipeline-perspective.

She would also like to meet with the Conservation Commission, the Planning Board, the Historical Commission, the Board of Selectmen, the Town Manager's Office, the Trails Committee and the Recreation Department. Member Cheryl Doyle said she would join Phelps for any meetings she can attend.

species and keep their numbers down as the older plants die off.

"For example, there are a lot of Norway Maples on the site in the middle, and we're not saying we should cut them all down," Carlson said. "They're providing a lot of ecosystem services right now, but I think as a lot of them are aging and getting older, targeting a couple for plantings and trying to think about what plants will survive in certain areas to increase diversity, that's kind of our endgame."

For historically problematic invasive species, both Carlson and Kuchar said the Town should look at all options. The most virulent species of Japanese Knotweed was a big talking point, and the pair and the ConCom agreed that all methods of control should be utilized so as to keep the plant from spreading out of control.

"It's going to be a measured approach and it's going to be an ongoing issue," Kuchar said. "Once it's under control it's not too bad, but it's the initial first phase which is tough."

"And generally it's not a one-and-done process," said Carlson, adding that for things like knotweed, all methods should be on the table. She said actual implementation will be up to the contractor.

For other design elements, Carlson said they are looking at making at least several of the trails accessible as defined by the Americans with Disabilities Act (ADA) and provide a connection to Elliot Park.

"And provide passive recreation opportunities like these picnic benches and other opportunities for interpretation and education," she said.

Carlson also said there are cul-de-sac-like areas at the end of the Saint Streets (St. Joeseph, St. John and St. Paul) that they are looking to remove to reduce impervious areas.

"We'll be using pervious pavers as much as we can," she said.

Near the river, there will be two overlooks with benches to provide views of the Neponset River and a boardwalk, which Conservation Agent Holly Jones said is being designed free of charge to the Town by resident and retired engineer Jerry Hopcroft. Jones pointed out that the Town does not have to do a bid process if the design work is being volunteered.

"He impressed me recently with a boardwalk he helped design and lead construction for in Quincy as part of a Neponset River Watershed Association (NepRWA) effort, and he has offered to do the same for our boardwalks for this project," she said. "That could considerably reduce the construction costs of the project and he's already actually trained several of the Trails Committee members and our summer intern in doing surveying work."

Jones added that the Town is also looking to do the build process with volunteered work, adding the only costs would be for materials. That is, if they can find the volunteers.

Carlson and Kuchar added that the plans for a food forest are still on the table, for harvesting by humans and animals alike.

"The desire for this kind of food forest and this idea of habitat preservation creation, I mean people were really excited for all the wildlife they see there, and so if you look at our plant list, there are a lot of plants that are edible for humans and foragers and a lot of them are for animals," she said. "That's kind of where we landed."

The Board voted unanimously to accept the plan for the park with a certificate of compliance and the usual standard conditions of approval.

highway and so it's being managed by design engineer VHB, which happens to be our engineer for the project down at Prospect Street."

The project at Prospect will also impact traffic, as it will install a traffic light as well as make safety improvements to the intersection.

"We're looking at a bid date of this summer or early fall for

that project, which is state and federal funded," Ryan said. "That construction, I'm going to guess, won't start until the spring of 2024. The rest of 2023 will include bidding, getting all the paperwork, submittals and schedules done."

According to the state's website on the Prospect Street project (https://tinyurl.com/ yhfahx4u) the project design has been finalized and the total cost is estimated at about \$8.5 million.

As far as the current project at Upland Road and Upland Woods Circuit, the light signal itself is scheduled to arrive in November and would be operational by January at the latest, though Ryan said he hopes it will be sooner than 2024.



### My State Pension Eliminated My Social Security Survivor Benefit

Dear Rusty: My husband of 21 years died in January 2022 at the age of 70. We were both retired at the time of his death, and they immediately stopped his Social Security payments. After many calls to Social Security asking why I was not receiving his benefits, I was finally told since I have my own pension from the State of Ohio that I would receive none of my husband's Social Security.

I cannot see why my OH retirement has anything to do with my husband's Social Security. I do get a small payment from SS based on my past earnings before I worked for the State of Ohio. Is there any chance of fighting this since we were married when they took money from his earnings for SS? If I wanted to write to an elected official to see if these rules could be changed, who would I write to or call?

Signed: Upset Widow

Dear Upset Widow: Unfortunately, your entitlement to a Social Security survivor benefit from your husband is affected by a provision known as the Government Pension Offset, or "GPO," which affects any surviving spouse with a federal, state, or local government pension earned without contributing to the Social Security program. Ohio is one of 26 states which have opted not to participate in Social Security, thus exempting state employees from paying Social Security taxes on their earnings. The OH state pension which resulted from your state employment means that any Social Security benefits earned outside of your state employment are reduced. The GPO reduction to your survivor benefit is severe - a reduction by 2/3rds of the amount of your Ohio state pension, which can - and often does - completely eliminate any SS survivor benefit you might otherwise be entitled to.

For clarity, the monthly SS payment your husband was re-

ment benefit-their personal SS retirement benefit offsets their SS survivor benefit, so a spouse with a regular SS retirement benefit higher than their deceased spouse's benefit gets no surviving spouse benefit.

FYI, the State of Ohio has an obligation to make clear that by not paying into Social Security your future SS spousal/survivor benefits are affected. Without knowing how that was presented to you during your OH state employment, here's a quote from Ohio's Public Employee Retirement System (OPERS) website: "If you are eligible for Social Security benefits and are receiving a retirement benefit from OPERS, your Social Security benefits may be affected by the Government Pension Offset or the Windfall Elimination Provision. The Government Pension Offset may also affect you if you are eligible for Social Security benefits through your spouse. The Windfall Elimination Provision may affect you if you qualify for Social Security benefits due to your own work history."

In any case, you are certainly not alone in your feelings about how your Social Security benefits have been affected by the GPO. This provision was enacted in 1983 and has been challenged in just about every Congressional session since that time, without success. In fact, there is a legislative bill active in the current Congress – H.R. 82 - The Social Security FairnessAct - which was introduced on the House floor in January and "referred to committee" for consideration. Like all preceding WEP/GPO reform bills, this one sits idle in Committee. If you wish to add your voice to those who oppose the GPO, you should contact your Congressional Representative to solicit action on H.R. 82.

At that point, your eligibility for additional SS benefits from your husband was assessed and, because of the GPO, Social Security offset your potential survivor benefit from your husband by 2/3rds of your Ohio state pension, which apparently eliminated your survivor benefit. As unfair as this may seem to you, note that the same thing happens to any surviving spouse who also has their own earned SS retire-

could also make it easier for the public comment period.

"So if it's hybrid, folks can still catch it on the tailend of their workday," he said, adding there was a bit of a selfish component to the time change. "And for those of us who are up starting their workday at 6 a.m., it'd be nice to have a 4 p.m. meeting and not a 5 p.m. meeting."

Town Manager Tony Mazzucco said he'd appreciate it as well.

"Selfishly, I think it would be better because some nights I have two meetings. Not that I want to make night meetings, but 4 p.m. makes it possible."

The only reason the MSBC didn't cast a vote is because Stewart pointed out there are four other School Committee representatives who she would like to inform. MSBC Chair Alan Slater said they would have it at the top of the agenda next meeting.

In other news, the Board voted to begin the process of adding about \$700,000 to the main project budget from the contingency budget for the construction of a loading dock at the middle school that was not previously budgeted for.

Boudreau said they haven't arrived at a final price for it yet. Riccardi said the loading dock is essential for the school, since food deliveries and trash removal will take place at these locations.

"I don't think we can adequately function as a facilities group inside that building without the loading docks," he said. "The compactors are top-loaded and they go to the top of the loading dock so you can throw stuff in, instead of throwing it up and in from the ground. Most trucks show up without automatic tail lifts to make adjustments to get down. It will make shipping and receiving much more difficult (without them)."

The contingency budget currently has \$3 million in it and so the project is nowhere near going into the red.


