School Committee concerned about proposed property purchase

The School Committee met on Wed. Oct. 26 in Norwood High School's library as it kicked off its series of "traveling School Committee" meetings that will take place throughout the district.

A key topic of discussion was Article 12, which is on the warrant for the upcoming Special Town Meeting on Monday Nov. 14. Committee members made it clear that neither the School Committee nor the Middle School Building Committee (MSBC) had ever voted upon or requested that the property described in the article be purchased by the Town. This article was approved in a 5-0 vote by the mately \$150 million and allow

warrant.

who acted as the chair in the absence of Chair Anne Marie Mazzola, said there was "some miscommunication" about the article, which talks about acquiring three properties in front of the Coakley Middle School – 1271, 1281 and 1297 Washington St. These properties are near Hawes Pool and the adjacent pond. They are also close to the Endean conservation area, trails, the Morse House, and the new fields anticipated for the new school building.

Town Meeting voted last spring to approve construction of the new building for the Coakley that will cost approxi-

Board of Selectmen for the it to include grades five through eight. This is the larg-Vice Chair David Hiltz, est capital project in the Town's history. The new building is expected to open in the fall of 2025.

> "The goal is to have the total cost of acquisition of all three properties, including funds to demolish properties, not to exceed \$2.5 million, assuming all three properties sell," the warrant's yellow sheet stated. Funds for the project would be bonded over a 30-year period if the article is approved.

The rationale behind the purchase is that the land could be used by the school as well as for recreational purposes. It would complement the renova-

New Director, public nurse approved by **Board of Health**

The Board of Health at its Oct. 24 meeting welcomed and appointed two new Health Department staff members to the team: Connor Brosnan and Diana Hillery.

A Norwood resident, Brosnan was appointed unanimously as the new Drug Free Communities Program Director, replacing Aubrey Ciol, who moved out of state. Ciol ran Impact Norwood, a substance use prevention coalition.

Brosnan is no stranger to the Health Department. He previously was a public health associate whose position was funded by a state Public Health Excellence grant. The shared service district he served encompassed Canton, Dedham, Milton, Needham, Norwood, Walpole, Wellesley, and Westwood, with Norwood as the lead community.

"Connor is an example of an excellent employee who really proved himself with this grant," said Health Department Superintendent/Director Stacey Lane. "When this position opened up, it was a perfect transition for him."

The grant for Brosnan's previous position was going to expire on June 30, so the timing for his new role, which will be funded by a grant for five more years, was perfect, she explained.

Before coming to the Health Department, Brosnan was a school guidance counselor for a decade. He also worked at a nonprofit urban farm in Dorchester, where he met people with substance use issues.

"I've kind of been doing this all along indirectly," he said, noting that his experience at the farm helped him develop an understanding of why some people turn to substance use and how they cope with the recovery process.

Board member Carolyn Riccardi asked how he intends to "bring Impact Norwood to another level."

Brosnan said he is "looking to build a larger coalition," which includes volunteers needed to staff events. He also plans outreach to the schools.

Hillery, a registered nurse, was unanimously appointed as the public health nurse. She previously worked for a decade at Children's Hospital.

"We're very excited to have a pediatric nurse here," Lane said. "They know all the children's vaccines, and it just brings another dimension to the department."

Riccardi warned.

"We're used to that," Hillery replied with a laugh.

Chair Kathleen Bishop said a future hope is to expand the Health Department's pediatric services.

In other news, Francesca Golightly, the program director for mental health awareness training, gave a summary of the program's first year of activities. Mental health awareness training has been funded through a multiyear grant, she said.


There were four mental health trainings over the past year, Golightly explained, where 62 Town of Norwood employees received instruction in mental health first aid.

"We're working our way through each of the departments," she said, noting that all of the Recreation Department's full-time staff members have received training. In addition, Human Resources Department employManager's office were trained.

"For year two, we're going to start working more closely with the schools," Golightly added, with two trainings scheduled for administrators and staff already scheduled in November that are specifically tailored to each department. Her hope, she said, is to plan training for teachers on days where professional development already is scheduled. The hybrid training sessions last for six hours, and there also are shorter pre- and post-sessions.

"I think there is a huge need for students to have access to services," she continued

Grant funding of \$125,000 has been allocated for the trainings, Golightly's salary, supplies and marketing materials. Golightly said that four people eventually will be trained as trainers in mental



trained trainers will be paid.

"That's complicated," Golightly said. "My hope is to train somebody who's already on staff."

Board member Joan Jacobs questioned why federal grant money has to be returned. Golightly explained that the money was allocated for specific needs that were anticipated, such as supplies. The directory of mental health services translation was not able to be completed this year, so Golightly said she is going to advocate with the funding agent that the money roll over to the current year.

Epidemiologist Rachel Brase spoke about infectious diseases. While COVID-19 is becoming weaker as new strains develop, there is still some concern, as cases in children up to age 9 and adults between the ages of 30 and 39 as well as seniors age 80 and older are rising. She urged people to get the bivalent booster shot.

People who contract the newer variants experience symptoms that resemble the flu, she said, so some may not take it as seriously. The bivalent booster will help make COVID-19 symptoms less severe as well as reduce transmissibility.

"Public health is never boring," added Lane.

The next meeting will be held on Tues., Nov. 22 at Town Hall at 10:30 a.m.

tion of the new Hawes bathhouse and the renovation of Hawes Pool, which the article said would cost "several million dollars."

Hiltz, who also is an MSBC member, explained that Town Meeting is being asked to vote on whether to acquire the three properties, as two of the three owners have expressed interest in selling them to the Town.

Of particular concern to all committee members was the statement that began, "While the Middle School Building Committee had asked the Board of Selectmen to look into these properties."

"The language on the yellow sheets took us – the School Committee and our administration – a little bit off guard," said member Teresa Stewart, who is also on the MSBC. "At no time was there a Middle School Building Committee vote to ask for the land to be acquired or to ask for the Board of Selectmen to look into this on behalf of the Middle School Building Committee.

"Further, as a School Committee, this body, we have never discussed it or requested it as additional school property," Stewart continued. "We just feel it is very important to clarify – both as a School Committee and those of us who are on the Middle School Building Committee – that we have not requested this."

"The way a committee endorses or does not endorse something is not just through open conversation," Hiltz stressed. "That is done through votes."

He added that "one of the boards was not direct in communicating with us," although he didn't name that board.

"And a phone call or, you know, a reach out to the committee would have been appreciated," Hiltz continued.

Stewart explained that the MSBC doesn't have the authority to ask for the land purchase. That would come under the School Committee's purview.

"So the only connection between this property acquisition and the middle school project is in fact the geographic location?" member Joan Giblin asked, which Stewart confirmed.

Thomson said the topic was brought up at an MSBC meeting in July or August 2021 as he looked for back meeting minutes.

"It was not voted on," he said. "But there was discussion that it was not going to be part of the building project. It was basically, you know, a Board of Selectmen decision which they obviously have voted for."

He added that the purchase "makes sense" because of the parking issues that will occur between the school, the pool and the ballfields.

"I just want to reiterate the scope of authority," Stewart stressed. "Whether it is a good idea for the Town or not, that is up to Town Meeting to deliberate."

The other major issue brought up as part of a packed agenda was the results of the MCAS scores in the district.

Assistant Superintendent Alec Wyeth explained that Norwood's results reflected those of the state as a whole. Scores, particularly in English Language Arts (ELA), declined over the last two school years because of the challenges of the pandemic and online learning. However, math and science results increased slightly, with Norwood doing well in math compared with the rest of the state.

"Basically one of the big takeaways is we have a long way to go to recover proficiency and learning losses from before COVID," he said, noting it could take several years.

Grade 10 students hadn't taken an MCAS test since 2019, Wyeth noted. There was no testing at all in 2020, and 2021 was "a mixed bag of effectiveness" because the year was partially in person and partially remote. Grades 3 through 8 were given a modified version of the test, so it is difficult to compare results from year to year.

The writing portion of the MCAS "had historically low scores" both statewide and for Norwood in particular.

"The number of zeros on required essays increased from 19% in 2019 to 31% in 2022," he said, with scores ranging from zero to five for the writing portion and zero to three for conventions.

Early literacy "really took a big hit," Wyeth continued, noting that it may take five years to recover. He called 2022 scores "the new baseline" upon which to judge future results.

Absenteeism continues to be a problem, he said. During the pandemic, much of the ab-

senteeism had to do with COVID-19 cases or exposures.


There is a silver lining in math.


"The good news on the Norwood Public Schools front is that six out of the seven elementary [schools'] tests were above the state average," Wyeth said, at nine points above the average. He praised the elementary school instructors for their hard work in maintaining continuity in their instruction and called the math scores "pretty robust."


He did concede that it had been harder to teach ELA

online, with the grade seven and eight scores nine points below the state average. Much of the curriculum at younger levels focuses on reading out loud, which was difficult to achieve during the pandemic. Another factor in the low scores may be the recent influx of English language learners into the district.

"Our middle school kids, I think, really struggled coming out of COVID," he added, noting that the academic challenges in some cases have been coupled with behavioral issues.

The Norwood Planning Board voted unanimously at its most recent meeting on Oct. 24 to approve several requests from Alexandria Real Estate Holdings to turn much of the streets accessing the Moderna Campus into driveways.

To be clear, the areas are already restricted to employees.

But turning these into driveways will, according to attorney representing Alexandria Phil Macchi, officially cut off public access to Moderna's facility at three points, but allow traffic to enter the apartment complex, known now as Cottonwood One Upland Apartments, and the old Forbes Hill Mansion.

The area is currently cordoned off by gates and exists as a private way. Macchi said changing them to driveways would give Alexandria more leeway in how it configures its \$100-million-plus planned renovations for the site announced earlier this year.

The plan would codify existing access gates, and allow new ones to be built in the future, in three areas, basically cutting off public access in the southwest near the entrance to Cottonwood, one currently at the entrance to Tech Drive and one right after the access to the Forbes Hill Mansion.

He said Tech Drive for instance won't exist when the renovations to the site – approved at the Spring Town Meeting - are finished and ready to go.

"When the smoke finally clears years from now and the campus is completely built up, this driveway won't be here anymore and they'll be accessing around the borders of the property," he said.

Planner Town Paul Halkotis said the plan has been vetted by the Norwood Police Department, the Norwood Fire Department, Moderna officials and several other related Town departments.

"We spent at least a month going back and forth between the Engineering Department, Police and Fire and representatives from Moderna on how the building numbers would be issued," he said. "Moderna had for its own reasons proposed a street numbering scheme and when that was presented, we had differing opinions from the police and fire departments on how that should work."

Halkiotis said eventually the state was brought in and a compromise was reached between all involved.

"It has to do with their filings with the FDA and coming from a single address. That didn't jive well with the very practical reasons that police and fire wanted to have an orderly sequence of building numbers so in an emergency event they could get there quickly. We were able to work that out and came to an understanding with the Engineering Department: we will only issue street numbers when there's a building present. When there's a building proposed, we don't issue street numbers for vacant lots. So now as time moves forward and they are building new

She has served as women's basketball coach at Stonehill for more than two decades, having added titles and responsibilities for the larger athletic department along the way. Earlier this year, she became the second Stonehill women's basketball coach to amass 400 career wins.

Ali Maloof graduated from Norwood High School in 2011. She was co-captain of the girls' hockey team, described in the Tiot yearbook as the "most successful season in Norwood history." At Southern New Hampshire University, she became a standout in softball, where she qualified for all-region and allconference (Northeast 10) honors, including recognition as Pitcher of the Year as a senior. In 2021, she was hired as head softball coach at Stonehill College.



ZBA approves dog daycare/ kennel for Railroad Avenue

The Norwood Zoning Board of Appeals (ZBA) met in a hybrid format on Oct. 25 and voted unanimously to approve a special permit to allow a new dog daycare and kennel service at 169R Railroad Ave.

Development attorney representing owners Paul and Mary Malloy, David Hern, said the couple is working under You Lucky

Dogs Norwood LLC for the location near the Depot grated from Ireland and are MBTA Station.

"That location was formerly used as a body shop and for repairs," he said. "What the Malloys propose to do here is to open up a business that will provide dog grooming, which is allowed as-of-right in the Central Business district, which this is in, and to do dog daycare and some overnight kenneling of dogs, which requires a special permit."

Hern said the couple emilooking to put their past experience training dogs to good use.

"Mr. Malloy has trained and continues to train hunting dogs in this area and Rhode Island," Hern said. "In Ireland, they worked training dogs and he still does it to some extent. Mrs. Malloy's family was also involved in training dogs in ZBA

to put in materials that will provide soundproofing," he said. "He's experienced in the building trades, he's an excavator now, and he knows what goes into buildings. He has a plan for taking reasonable steps, I think, even more than reasonable steps, at soundproofing the building, because that is always a concern, particularly for neighbors."

Hern said specifically, cinder blocks themselves are ideal noise blockers, but added Malloy would include an air cavity in construction to block out even more noise.

"He will also then put up a kind of insulation that will provide additional soundproofing, and then a type of plasterboard or soundproofdrywall ing called QuietRock, so that as much as possible, it's going to limit noise," he said. "He's taking every step possible so people won't hear. We're not talking about huge numbers of dogs there."

Malloy said he expects about 30 dogs a night to be their max for the kennel.

"The projected number of dogs we're thinking is about 20 to 30, but I have dogs, I have kids, and this is like a daycare; it depends who shows up," he said.

When a gas leak is not a gas leak

The Norwood High School was evacuated last week out of an abundance of caution and common sense when the smell of gas was detected by several persons in the building.

"It really wasn't a gas leak, as far as we could tell," said Norwood Fire Department (NFD) Chief David Hayes. "We got called for a smell of gas on the second and third floors in the back near the field and there was a smell, but it was mercaptan."

Natural gas is odorless, and so that distinctive additive is put in to make sure it can be detected once it's in the air. Hayes said it was more likely that the smelling agent was there in high amounts rather than the actual gas.

"We think that's what they smelled," he said. "We called the gas company and when they arrived nobody's meter picked up any level at all. We suspect it was just the chemical itself, and out of an abundance of caution we closed the school for that day. Our guys went back over and tested it again when the school was closed up to see if it was still there. We also went back the next morning and retested everything and we had nothing, no smell at all."

Haves said the smell could have come from some sort of chemical leak in the building or something less than accidental.

"I hate to accuse anybody of anything, but it could have been like a stink bomb," he said.

Hayes said despite the fact they were all pretty certain it was not actual gas, it was better to close the school to be on the safe side. The smell is meant to alarm people to the presence of natural gas so people are naturally concerned when that odor is present. So it wouldn't be a good learning or working environment for people if they were constantly smelling something so closely linked

with an explosive gas.

"Our meters actually test the flammable limit, and they alarm at 10 percent. We never went into alarm," he said. "We never detected any flammable gas at all... To be honest, the administration has to deal with a bunch of kids complaining that they smell gas all day, so I think they did the right thing by closing the school."

Natural gas is actually not as flammable as many might think, and it needs to reach a specific range of five to 15 percent in the air to easily ignite. Anything under that doesn't have enough gas to combust. Anything over doesn't have enough oxygen to support combustion. However, that doesn't mean it's not dangerous in other ways.

Natural gas contains volatile organic compounds. According to a study conducted this year by the American Chemical Society Climate Journal (https:// bit.ly/3NoBFBo), 69 homes were tested with 234 unique samples collected. The known carcinogen Benzene was found in 95 percent of those tested samples (164 parts per billion to be fair), pollutants hexane in 98 percent of samples, tolune in 94 percent, heptane in 94 percent and cyclohexane in 89 percent. The study cites natural gas leakage data to estimate that about 120 to 356 kilograms (264 to 784

pounds) of benzene alone is released into the air in Greater Boston every year.

According to the Home Energy Efficiency Team, thousands of leaks are reported in Massachusetts each year (https://heet.org/gas-leaks/gasleak-maps/), with some as old as decades. Hayes said National Grid releases a list of leaks for Norwood, and he said the company has been responsive to reports of leaks lately.

"Every now and then they put out a list of known leaks in Town, and the gas company has been really aggressive about fixing Norwood because I think our infrastructure is a little older than others. We had 100 known leaks that they judged to be not dangerous," he said. "Last I saw that list was probably a year-and-a-half ago. And our guys go out on calls all the time for smells of gas."

Hayes said the gas company will drill borings into the road or dirt to allow any gas to disperse directly and from that they can determine the level of a potential leak.

"I get daily calls. I got one at 10 this morning. And if they're significant, we go out. You know you've got contractors working on high pressure gas mains; those are a big deal. We had to evacuate the entire Lenox Street neighborhood by Mystic Studios about

eight years ago because we had a high pressure main just spewing gas into the air. They had to dig it and close it."

For residential systems, the highest danger is when the gas is restricted in some way. He said that happens more often during the winter when the ground is frozen and the gas gets trapped and can sometimes find its way into a crack in a house's foundation.

"You get a small leak when the ground is frozen and it acts like a roof and confines the gas," he said. "It follows the gas line back into the foundation... That's why in the winter time when a leak is reported the gas company goes into all the surrounding houses and checks the basements. Norwood in particular has a lot of gas meters inside of house, which is not my favorite thing as a fire chief; it's hard to cut the gas to the house. And sometimes the gas line will go straight through the foundation, and any cracks in the foundation will let gas into the house, which is really concerning to us."

Regardless, Hayes said for these reasons and more it's a good thing to call the gas company or the fire department if you smell gas around the neighborhood.




