## Planning Board open to idea of accessory dwellings

The Norwood Planning Board met on Monday and discussed a new zoning initiative to allow accessory dwelling units (ADU) for Norwood homeowners.

The main thrust of the ADU is to allow homeowners who meet the requirements to create an additional unit in their home or on their property. Traditionally, these are known as “in-law apartments,” as families generally use them to allow older or younger family members have their own living space while still being on the property.

Town Planner Sarah Dixon said she has incorporated several changes requested by the Planning Board previously, mainly dealing with the size of each ADU – basically using dimensional requirements to regulate the minimum size of

the unit and either 900 square feet or half the gross floor area of the principal dwelling unit for the maximum. The regulations would also require one separate means of egress, along with one through the primary dwelling unit.

“I think that’s a practical change and allows for two things,” she said. “It allows for more of the units that would be constructed as interior renovations to be permissible and I think it would create a more intimate style of housing.”

“It seems more like what we would think of as in-law apartments,” said Board member Joseph Sheehan.

“But we have that in our bylaws now?” said Vice Chair Debbie Holmwood.

“We do not, people put them in, but we don’t have them in our bylaws,” said

## Nucar renaming most Boch locations

The Automile in Norwood will be seeing – or in some cases, has already seen – a big name change along some of its most recognized dealerships.

Nucar (DCD Holdings), which had purchased the dealerships from Ernie Boch Jr. several years ago but maintained the rights to use the Boch name, will be now changing the names of several dealerships to Nucar, including the Honda, Toyota, Chevrolet, Nissan and Hyundai dealerships. Ernie Boch Jr. himself will be retaining Boch Masserati and Boch Ferrai (Ferrari of New England).

Nucar President Christopher Dagesse said the change in name will reflect the broader recognition of the company, since he said they now have dealerships in New Hampshire, Vermont, Massachusetts, Rhode Island and Delaware.

“We want to have one main brand with the driving force being some of the technology and platforms we’re working on” he said.

Boch said he wished the company luck.

“There is not one way to success; there are many,” he said. “Some people can’t handle a legacy company. I wish them all the luck in their future endeavors.”

Boch said none of this will affect the day-to-day operation of things, since DCD and Nucar have basically been running things since 2015, and added that the Music Drives Us campaign that donates money every year to the Town of Norwood will not be affected.

Dagesse also said they will not be touching Ernie Boch Sr.’s sign at the beginning of the Automile welcoming

residents to the local landmark.

“We would never touch that; just as homage to Ernie Sr. and Ernie Jr. and what their family has done,” he said. “We plan on – no, not plan – we will keep that up, absolutely.”

Dagesse said the Nucar website will allow customers to search all of Nucar’s locations to find a vehicle to purchase and have that car shipped easily no matter where it is.

“Everyone’s doing that today,” he said. “What we’re trying to do really is integrate what we call the cash register. It allows the customer to start it (car search) online, and finish (purchase) in store. We will work from that same tool.”

Dagesse said right now they have various systems among themselves, the customer, financiers, the accounting system, inventory management, and more that don’t really “talk to each other.” He said they are working to upgrade and simplify their system to both increase efficiency and, hopefully, improve customers’ experiences.

“We want to make it eventually so that the exact website you use at home will be the exact website to do your deal

## Norwood's Gallery Hop

This past Friday, despite the rain, Custom Art Framing & Gallery, and Tax Solutions Inc. partnered together and hosted a Group Exhibit and Gallery Hop. Both of the locations house and sell art full-time, and try to have events like this one, once a month, to show off their artists.

Custom Art Framing & Gallery had an array of frames, as well as a variety of paintings, photographs, pottery, and even purses made out of newspaper (hopefully not this one), from a number of different artists. The paintings were created with charcoal, acrylic, oil paints and pastels; and ranged from scenic paintings of Europe, to a can of chickpeas being squeezed with a wrench.

The paintings were definitely eye-catching and took up almost all of the free space on the walls, with more paintings in slings on the ground. In the middle of the room stood a table with a variety of pastries and a bottle of wine.

Community members came in and out, snacking on the food, drinking their wine, admiring the art, and everyone seemed to have a chat with the owner Julie Vecchio.

Vecchio owns and works at Custom Art Framing & Gallery full-time. She opened the shop in 2003, and has made a name for herself within the community.

"I've always been interested in framing," Vecchio said. "My dad is an artist, and so are my two sisters, but I am not. So I have always enjoyed framing art." Though her husband exclaimed that she is a great artist.

Vecchio said she has lived in the Boston area her entire life and has many connections to the community. She focuses on picking local artists for her gallery.

"It could be Cambridge or Canton, but local is best for me, it's part of our thing," Vecchio said. "Overall, it is what I think will sell or what I like, so all of this art is kind of personal to me. I like to have an eclectic mix of

art and different mediums. All sorts of fun stuff."

Vecchio said that this is the first time cross-promoting with Tax Solutions, located down the street.

"We are sharing a clientele, which I like, as well as getting to meet other people that may not have come here," Vecchio said. "Cross-promoting is great because you get to have fun with and meet new people while exposing new people to the shop and to new artists."

Susana Murphy, the owner of Tax Solutions Inc. felt the same way.

"I am not from Norwood," Murphy said, "so when I first started my business I didn't know anybody. I have a bunch of Boston-based clients, that's kind of why I picked Norwood, but I didn't know anyone within the community. So this for me has been fun because I got to meet a lot of local people and businesses."

Murphy is an accountant, but is also a classically-trained ballerina. She said that she kind of fell into the arts through that.

"I moved into this place, and I had these huge walls and had no idea what to put up," Murphy said. "You know when you just put a boring picture up and it stays there for like 10 years, I didn't want my walls to be like that."

Murphy said she met local artist marypaz who knew exactly what to do with her empty walls. marypaz introduced her to many local artists and ended up displaying their work on her walls. She said that marypaz did almost everything and was even the brain behind this Gallery Hop event.

marypaz has been promoting artwork in Norwood for a while with her Art!Walk events. She said she also has plans to start a nonprofit with other community members interested in art, called "Art!"

Now, Murphy has several paintings of nine different artists covering her walls, from abstract art to delicate scenic paintings.

Murphy said she takes no

commission; for her it is just important to raise awareness for these artists and their pieces.

## GOOD DEEDS: Why We Give

As we prepare our holiday gatherings and frantically search for just the right gift to give or dish to serve, we are inundated with hundreds of items to choose from. Will it be turkey or ham? Mashed or sweet potatoes? Should I get someone a bike or a video game? The options are endless. Another somber statistic, according to the charity Family Action, is that one in seven parents will unlikely be able to afford Christmas presents for their children this year. Based on the number of children in the United States and the average number of children per family, nearly 2 million children will go without a gift this holiday season.

# SNC hosting annual Christmas Party at Morse House

The South Norwood Committee (SNC) announced this week it will be hosting its annual Christmas party on Dec. 14 at 4:30 p.m. at the Morse House.

SNC member Tony Eosco said the party will celebrate the neighborhood, as well as help to highlight progress on the Morse House's historical preservation work. The Morse House, and the possibility of updating the building, has been the subject of much debate over the last year. The Morse House Subcommit-

tee managed to get several requests for funding approved by the Community Preservation Committee (CPC) for Phase 1 to rehabilitate the building, which started with stabilizing the structure.

The SNC hired a consultant for \$10,000 to figure out how to get the house on the National Historic Register which will, hopefully, open the door for future grant funding for a full rehabilitation. The rehab has been split into three phases, with the first underway now. Phases 2 and 3 will be determined by the subcommittee based on priori-

ties.

Both of those phases represent the majority of the work and the Morse House Committee has intimated that it will fund those phases with grants and donations. The stabilization of the house was funded at \$192,000 with Community Preservation Act (CPA) funds at May's regular Town Meeting, and it included work on the foundation, clapboard siding, windows, doors and other exterior elements.

Regarding the preservation consultant, Eosco said they're hard to find at this point.

"We are still seeking a pro-

fessional preservationist – they are very busy and hard to get these days but we are still very hopeful of finding someone soon," she said.

In terms of work, Eosco said they have just completed the support beams in the basement, which were originally wooden, as well as painting the outside and shoring up the foundation. They are still looking to replace

the windows, and there is a lot more work to do in Phases 2 and 3, but she said the house can wait longer, as it has stood the test of time over the years.

"That house was built to last," she said. "It's just one of those things about those older homes,

by Norwood native Lee Kennedy more than 20 years ago in memory of her daughter Michelle.

Michelle Kennedy fought a long battle with leukemia before succumbing. She said to her mom Lee that she was not only grateful for the support she got from her friends and family, but also from residents of the Town who didn't even know her, and she wanted to do the same for others when she got better. Michelle ultimately lost her battle, but Lee Kennedy has continued the mission and the COH has provided more than \$1 million in charitable donations to residents in Norwood in need since that time.

Lee Kennedy said she's always amazed every year at the support the COH gets through the Luminary.

Dixon. "That's the whole intention here, is to try to codify something that has been going on without any kind of oversight."

Dixon said there is a huge demand for these types of apartments, especially after the pandemic, where residents don't feel as comfortable as they may have in the past using care homes for their elderly relatives. The annual increases in costs associated with those care homes may also be a factor.

One point that the Board agreed on was that the ADUs should not be detached units from the principal structure. Members said they felt it could open up neighborhoods to investment rental firms (however, according to Stateline and CoreLogic, investors bought 24 percent of all single-family homes purchased in 2021 and 22 percent in 2022 [<https://tinyurl.com/bac5z9zj>] for renting investment purposes, and single-family renting has been a huge issue since at least the 2008 financial crisis).

The general consensus of the Board was that having an ADU in the principal property would cut down on those ADUs being used as rental properties, as the "intimate style of housing" would be less conducive to strangers living in the same house.

"There are certain neighborhoods where there might be housing stock that are viable opportunities for investors to buy up a series of these 1920s-style

ranches, 1,200-square-foot houses," said Chair Brian Hachy. "It makes sense for them to buy them, rent them and build an ADU which would transform the neighborhood from an owner-occupied family neighborhood to a – and nothing against renting property, I have no issue with that – but I wouldn't want to change the entire character of neighborhoods in Town. Maybe it wouldn't happen but it is a concern."

Dixon said given the sizes of the average lots in Norwood, she didn't feel too many parcels would work for detached buildings. She said in her time working in Westwood, where they had an ADU bylaw, most of the applications were for finishing existing spaces like basements, attics or garages.

"That was very common; finishing the spaces above a detached garage," she said. "Now in Norwood, the properties are smaller, the homes are older, there may not be as many of those, but I don't want you to just think of the tiny home. That is certainly one part of that, but you may also be looking at requests for people to finish off spaces they already have."

Holmwood said she felt most of Norwood's housing stock would require a detached building to be really close to the principal unit anyway. Member Ernie Paciorowski said he did not like the idea of accessory buildings being used for rental.

The Board agreed to continue the discussion.

The Board also continued its discussion from its last meeting around the MBTA Communities Act, known as 3A. While members toyed with several smaller ideas around the proposed zoning, it remained largely as is. The biggest potential change would be the Board asking Dixon to calculate how increasing the maximum number of parking spaces per unit from 1 in the Norwood Central District to 1.25 spaces per unit would affect the total build out unit count that could be accommodated. Dixon said she would get back to the Board on that. Also discussed was the idea of offering different ways for developers to potentially increase their density on projects if they provided certain amenities or commercial spaces, but nothing was finalized at the meeting.

In other news, Attorney David Hern asked that the discussion on the Major Special Permit Site plan for 83 Morse St. (the Space Center) be continued until Dec. 18. Hern said they have made some changes to the 146-unit proposal and have received some comment from relevant officials on those changes, and want to use that extra time to respond to any additional concerns and work out any kinks that might arise. The Board voted to approve the continuance.

Driving LA to San Francisco, I decided to turn off for Cholame. Exiting the 5 onto 46 West immediately throws you into oil fields, the pavement crowded by slowly gesturing derricks, their arms rising and falling as though waving you onward, toward distant hills.

Signs: "Fresh Cashews & Almonds," and soon a Pacific Almonds plant, on the right. The road follows a finger of flatland into a breach in the hills, then climbs a low, 1750-foot pass. The Twilight Zone Effect: while passing a slow-moving Gene's Auto Transport truck carrying a 1950 Chevy, Bing Crosby comes on the radio. Road signs join the irony: "Daylight Headlights ON." "Click it or Ticket," and, "Enjoy Meridian Wine—Live A Little."

Sal Locaino is a happy, middle-aged soul, always smiling, always chatting on the jobsite. He's a good guy to work with, as he buffers indifference or hostility between various crews. He sees through common working tensions, or doesn't see them at all, or simply doesn't care. Sal, to exhale the common cliché, is a breath of fresh air. Years ago in Fresno, Sal, bouncing up and down on the balls of his feet, pointed to a local electrician working nearby.

"Know who that is?"

"No," I replied, glancing over. The man had no distinguishing features, but appeared simply a lean, be-spectacled, sixtyish-year-old electrician, engrossed in his work.

"No."

Wending westward through soft, bare Californian hills, a sign for Cholame appears which, in salted imagination, I sensed is roughly translated from local Motale Indian for, "Slow the heck down." Crossing the height, I descended into the bowl holding the Routes 46 & 41 intersection. Here, at 5:59 P.M. on the night of September 30, 1955—shortly after receiving a speeding ticket—James Dean, a rebel without a pause, raced down this same hill for his final act. As best could be determined, unaided by a shaken Donald Turnupseed who insisted at the scene, "I didn't see him, by God, I really didn't see him," the soon-to-be Hollywood icon's Porsche Spyder collided with the unknown but soon-to-be-infamous Cal Poly student's 1950 Ford Custom Deluxe Coup.

The 24-year-old emerging legend died in an ambulance shortly after, while the 23-year-old future electrician hitchhiked home to nearby Tulare. Sal approached me later in the day, bouncing up and down on the balls of his feet. I have since read that Donald Turnupseed was famously silent on his unfortunate celebrity, but Sal, unsurprisingly, had engaged him on the subject during a cigarette break.

"I talked to him, know what he told me?"

"What did he tell you?"

"Said he still has the car! Still has the car he was driving that night. It's in his garage. Been in his garage for forty years! Told me, 'It's my retirement.' Imagine that? It's his retirement!"

I paused at the intersection of present trails, disappointed to learn it has been relocated a short distance from the original crash site, which lies now in an adjacent field. I loitered little as scornful, rolled-eyed local glances, long impatient with eager-eyed tourists, urged me on.

I drove through the small, poverty-blown town of Shandon and onto an original, narrow and black-topped section of Route 46. I pulled back onto new Highway 46 and continued west. I saw a church with a sign that continued the theme, "Drive With Care—Life Has NO Spare." Through the vineyards of Tobin James, Derby, and J. Paul Rosilez I passed, and as I drove, I thought: twice during recent economic downturns, Americans had lost half of their 401k's. So Turnupseed's

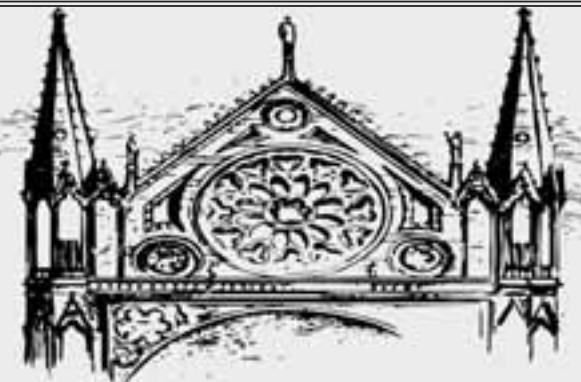

portfolio, weighted heavily with Famous Wreck, seemed a great idea. An American idea. Take care of your retirement yourself, no one else will.

Somewhere in the vast openness of central California, thirty miles east of Eden and Pasos Robles, is a lonely intersection at which people still gather on the anniversary of James Dean's death. In a moment on one dimming day, two youngsters had their lives changed forever there. One a blossoming movie star, a kid who'd never have to worry about his retirement, the other

an engineering student who would save that evening's wreckage, in anticipation of his own.

But I know what happened to Donald Turnupseed. Shortly after Sal Locaino and I worked with him in Fresno, Donald Turnupseed was diagnosed with lung cancer. He died two years later. James Dean didn't even make it through that fateful night. Both had, through their own individual efforts, secured that fabled American Dream, a secure retirement. Neither, as it turned out, needed one.

Plan accordingly.

## NCC pitching cultural district(s) for Norwood

The Norwood Cultural Council (NCC) held an informational session on Tuesday night at the Morrill Memorial Library to a group of about 15 residents, artists, business owners and 83 Morse St. developer David Depree to pitch the idea of creating one or more cultural districts in Town.

A cultural district is basically a tourism label that, after a municipality has successfully applied for and received said designation, would give the Town access to funds and funding opportunities based on arts, humanities, sciences, cultural businesses and more. NCC Secretary Arati Paranjpe led the discussion and said that the district would give the Town access to a yearly grant for each cultural district that gets approved.

The funds adjust with what's approved by the state legislature, and Paranjpe said for this year, each of Massachusetts' cultural districts got \$15,000 to use as discretionary funds for cultural enterprises. This bucket of \$810,000 for each district changes year to year, but Paranjpe said the district designation also opens up opportunities for other grants and investment opportunities from private entities to help highlight what makes a district unique and, hopefully, make it a tourist destination for Massachusetts residents and beyond.

Boston currently has two cultural districts, the Latin Quarter in Jamaica Plain/Roxbury and Little Saigon in Fields Corner

Dorchester. The districts help highlight the cultural and artistic offerings in those neighborhoods of Boston and promote what curious visitors might like to see. In Boston's Latin Quarter, it has helped to highlight and create public art with local artists. In Little Saigon, it has helped create events like the Dec. 9 Gala at Chau Chow Restaurant on Morrissey Boulevard, which features live performances, food, dancing and community awards.

The way that Paranjpe described it, it can help create a sense of place. That might sound ethereal and fleeting, but it basically means creating a landmark. Currently, Norwood is known for the Automile, which is an achievement, but is it all Norwood wants to be known for is the question.

Paranjpe said they are still in the preliminary stages of the designation process, and nothing has been decided, but they were looking at possibly two districts: Downtown Norwood and South Norwood. She said there are four types of districts: a town center dedicated district area, a cultural production focused cultural district area, a creative arts and entertainment district and a natural eco-friendly focused district.

Morrill Library Executive Director Clayton Cheever and Paranjpe said an eco-friendly district would include parks and trails. A town center district would promote local history – like the districts of Lexington and Concord, which help to tell the story of the Cradle of the American Revolution. A cultural production district would promote things like cultural artifacts and local cuisine

and a creative arts district would promote artistic endeavors.

Sustainability Commission Chair Peter McFarland expressed doubts at the meeting on the feasibility of doing more than one district. He said it's hard enough now to get residents to reliably show up to committee meetings and other such events to organize, and said it would be better to focus on one district.

The idea of two districts, according to Paranjpe and Cheever, is to create areas that are walkable – which is also a requirement of the district structure. A local artist also chimed in and asked what if a studio is not directly in the district, would it still get any benefits. Cheever said the idea is not to exclude anyone, and though one's studio or space may not directly be in the district itself, it would still have access to funds and grants because it may contribute to the district.

Several residents asked about the funding structure beyond the annual stipend from the Massachusetts Cultural Council. Paranjpe said those change from year to year and depend on private individuals as well as the state to obtain.

photographer who displays work in Murphy's business, said that there are not enough outlets like this for artists.

"Any community that's strong, you'll notice, will have a strong arts side to it," Cardoni said. "And with places like the Winsmith Mills and Space Center, Norwood has been really building their art culture. Art has always been strong in the schools, particularly music, but also visual arts and video pho-

tography; everything."

He went on to say that having as many outlets as possible for art will strengthen the overall community, making it a more positive place to be. "Even when art is dark, it's still positive because it's art, it's expression," Cardonia said. "That's what we're trying to foster."

And this event did just that. Although it was raining, there was so much color, creativity,

and camaraderie throughout that one block in Norwood.

"It is important to connect artists; for artists to support other artists and to introduce collectors to other work," Vecchio said. "But most importantly at events like this, it is important to have a party."

The next reception is Saturday, Dec. 16 from 1 p.m. to 4 p.m. at Custom Art Framing and Gallery, Modern Eyes and Tax Solutions.

when you come into the store," he said.

Open lot storage of both new and used cars has been a major issue Norwood has had with car dealerships. The Town managed to convince DCD, around 2018, to sell a parcel of land it was originally looking to use for open lot storage on Morse Street. The Bernie Cooper Memorial Waterfront Park is what resulted. The Town also recently rezoned all of Route 1,

in part to cut down on car storage outside the Automile perimeter. Dagesse said this new system, at least with Nucar, could help alleviate that.

"We have another dealership, let's say for Toyota, in Attleboro and another one in Rhode Island, and so we could relieve some pressure up here – where space is limited and expensive – we've absolutely talked about that," he said. "It definitely comes down to

whether the manufacturers are okay with us doing that."

Dagesse said the manufacturers want to keep a certain amount of distance between the dealerships they use for their different car brands. He said another Toyota dealership may not appreciate having cars put up for storage – even if it's just for open lot storage – in its region because that could be construed as a form of advertising on their turf.
