Norwood mourns Tyler Lawrence

More than 450 residents, friends, family members and officials came out to the Revent Space at the Rama Center in Norwood on Sunday to mourn the death and celebrate the life of 13-yearold Norwood resident Tyler Lawrence.

Hundreds filled the parking lot of the Rama Center, with a line extending around the block for several hours. The event went from 2:30 p.m. to 5 p.m., and though at least 100 residents were still in line to pay their respects, organizers said the family was just too exhausted to continue. The event culminated in an address to the crowd from Lawrence's grandfather, Stanley Lawrence.

"The outpouring of love for my grandson is what's holding our family together right now," he said. "I never, in my wildest dreams, thought he touched so many people. We tried, as a family, to raise him to be a respectable young man, and I just wish everybody could have been able to come inside. The amount of people who came; I will never forget this in my life."

Stanley Lawrence said he was grateful to everyone who came out for the event.

Rush, Rogers accuse officials of misconduct

Town Meeting members on Monday, Jan. 30 received a heated six-page letter signed jointly by their state legislators that explained their position on H. 4287, a bill that would have granted Fire Chief David Hayes the ability to work in his role past the age of 65, a letter that also accused some Town officials of improper conduct while advocating for the bill's passage.

Several scathing accusations by state Sen. Mike Rush and state Rep. John Rogers emerged against Hayes, General Manager Tony Mazzucco and Board of Selectmen Chair Bill Plasko in their joint letter. Their veracity could not be confirmed by The Norwood Record by press time. Hayes and Plasko have not returned requests for comment by the newspaper. In an email from Mazzucco dated Feb. 2 to The Norwood Record, Mazzucco stated, "The town will respond when we're able to. It may be at the next selectmens [sic] meeting which is over a week away."

In a previous article, The Norwood Record reported that on Oct. 13, 2021, Mazzucco and Hayes signed a five-year contract, effective Sept. 1, 2021, that would have given Hayes another five

Backpacks to save lives

Richard and Bernadette Giacoppo have been collecting and distributing life-saving backpacks for almost four years now in and around the Greater Boston Area to whomever needs them. The difference with these backpacks is that they are for people struggling with addiction.

Their son Ricky died in 2019 due to an overdose at 34 years old. Richard said they started the charity RickyInc. about six months later going into treatment clinics, sober houses and hot spots like Mass and Cass to distribute the backpacks to those who need them.

"We decided we wanted to do

something in his name and his memory," Richard said. "He was a wonderful guy but he had this illness. Substance use disorder is the proper terminology. We were talking about what we could do, and to people who are facing homelessness or struggling in crisis, their backpacks are essential to them. Their whole lives are pretty much in their backpacks."

Giacoppo said they worked with his brother and set up an Amazon wish list for backpacks, personal hygiene products, treatment information and, more recently, they were able to secure permission to distribute NARCAN to residents.

Bernadette said, "Ricky suffered Backpacks Continued on page 6

"I want to thank the Town of Norwood in what they did for putting this on," he said. "Not too many towns I know of do something like this. From the bottom of my heart, I thank each and every person here."

Stanley Lawrence had trouble during his speech.

"I'm not a public speaker," he said. "I'm just a guy."

Choruses of "We love you," and other outpourings of support came from the crowd.

"From the bottom of my heart I want to thank everybody here," he said. "From the soles of my feet to the top of my head I thank you, I thank each and every person and I feel your love. I know Tyler feels it too. Thank you, thank you thank you, thank you so much."

Stanley Lawrence said there will be a wake and funeral for Tyler in the coming days and invited everyone at the event to come and pay their respects. At the time of publication, no details on this have yet been solidified.

Coakley Middle School Principal Margo Fraczek said she knew Lawrence as his principal. She said he was a joy in school.

"Whether he was walking through the halls with a giant smile and dabbing everyone he could – I know how to dab because of Tyler – or whether he was in the lunch room jumping from seat to seat to seat to seat – I would have to tell him, 'Tyler! Just pick a seat!' because he was just everywhere and friends with everyone and just a fabulous boy," she said. "I just want you to know that all of those moments will be with us forever."

Lawrence's godfather Ernest Bass said he missed Tyler greatly, and said he wanted to express his gratitude to the Town of Norwood for putting on this celebration of Tyler.

"I just want to thank the Town of Norwood for extending this time of celebration of his life down here," he said. "It's very nice of them and this is a great turnout. Tyler was a great kid and he was our baby. From the Lawrence and Bass family, I just wanted to say thank you." Norwood School Resource Officer Geoffrey Baguma said he felt the loss in the community, but said it was encouraging to see so many come to remember the life of Tyler.

"There are many students here from many generations showing up and showing love to the family and it's a great thing, it's a positive thing," he said. "I really want to leave it to the parents and grandparents to say how they want him to be remembered and how Tyler Lawrence can live on through us."

Lawrence was also involved with the Big Brother Big Sister Mattapan Chapter, and organizer Toffer Winslow said he will miss him dearly.

"I'll miss our opportunities to hang out every couple of weeks, I'll miss going apple picking in the fall, our opportunities to talk about the latest Fortnite season, and everything," he said. "He's a great kid. Tyler's been my match for the last three years. I can't really process something like this. It's such a senseless and tragic loss of a beautiful precious life."

Winslow said it was amazing to see how many lives Lawrence touched.

"I'm really heartened to see that there's such a great turnout and the family knows he was a boy who was loved and well-liked and everybody knew him to be a good kid," he said.

At-Large Boston City Councilor Ruthzee Louijeune and State Rep. Liz Miranda (5th Suffolk) also came to the remembrance. Both said that while communities in Boston may seem like separate worlds, the only thing separating Norwood from those communities is artificial boundaries.

"One of the things I always like to tell people is that Mattapan, Wellesley, Norwood, it's the same thing," Louijeune said. "It's families going to work trying to provide the best for their kids and trying make sure the work is not their entire life in all these neighborhoods. All these cities are the same; what's different is probably your tax bracket, but that doesn't mean everybody isn't trying to get the same thing. The best schools for their kids, the best resources for their kids, good environments, good parks, we all want the same things. So part of our work is really to address the root causes of these things that are happening." "We came today to show solidarity with the young people suffering both from Mattapan all of Boston really - and Norwood and so this is a young man who touched a lot of people's lives," Miranda said. "This is an opportunity for leaders and those who consider themselves leaders to come together across geographical lines, across classes, across race, to say whenever a child is harmed, they're all of our children and

we all must come together. And so for anyone sitting at home reading the paper thinking, 'Why should I care?' This could happen to anyone, any of our children, anywhere in the Commonwealth of Massachusetts. There are communities that are more prevalent to violence and have less resources and we should be working to make sure any young person, regardless of zip code, have what they need."

No Books No Ball founder Tony Richards said he's known the family for several summers through the work his organization does to help bring down violence in Boston and beyond. He said Lawrence was a part of that program.

"He was like any other 13year-old that loves to live out their dream of playing college basketball and entering into the NBA," he said. "That was one of his dreams as well. It's just a travesty that his life was cut short and he was not able to live out those dreams."

The Afterschool Arts Program founder and Roxbury resident Dominga Martin said she left Boston when she was 17 because of the violence.

"But I was implored to come back home three years ago," she said. "I started the Afterschool Arts Program, and we had our first in-person summer, and on the second day, one of our young people, their friend was murdered. I said I'm not going to do this, I can't do this. Because by the time I graduated high school I lost 12 friends to gun violence. A dozen. I didn't know what my trauma was. But then the mother called and she said, 'I want my son to come back.' It had been five days since he was gone and he came back, and he's still with me. I'm here because this is cyclical."

As of the time of publication, an accused drug dealer already in court for a charge of fentanyl distribution is now being charged with Lawrence's murder, according to District Attorney Kevin Hayden's office. The suspect's name is C'Sean Skerritt, 34, and is expected to be arraigned in the

"very near future."

Creative minds will be given the opportunity to explore their visions of an improved environment through Norwood Solarpunk, a writing and art effort beginning this month that will lead to a digital book of compositions.

Co-sponsored by Together Yes, Progress Norwood and the Morrill Memorial Library, Solarpunk Norwood intends to engage people to share their visions of the future, according to Susan Clare, the founder and director of Together Yes. It is part

School also will have a separate gallery to share their submissions, spearheaded by the Environmental Youth Coalition (EYC). She described it as "a moment of hope" in the battle against climate change.

"This is very different from an international writing contest," Clare explained. "This is not a juried contest; it's a chance for local people to really use their creativity from the heart. None of the work will be copyrighted, and most of the artists and writers will not be professionals. We are doing this for our neighbors.

Students from Norwood High reading. Clare said she hopes the digital book will be online for Earth Day on April 22, when Progress Norwood will hold a number of activities focused on the environment.

> "Most of the news we hear is about a small proposal from the government," Clare said, "and it is not guaranteed ever to happen. We find a lot of pieces address the struggles. If we listen to scientists and meteorologists, the outlook on climate change is not good."

> By contrast, Clare noted that the focus of solarpunk is unabashedly optimistic.







of the library's ongoing sustainability series. A presentation about Solarpunk Norwood will be held at the Simoni Room of the library, located at 33 Walpole St., on Monday, Feb. 13 from 7-8 p.m.

Clare, a writer and the founder of the community garden, said she became intrigued about the concept of solarpunk when she attended the library's virtual lecture by climate fiction author and creative manager Tory Stephens in November. He described how people are turning away from dire mainstream media predictions about climate change and instead turning their focus towards fiction writing to uncover innovative ideas about solving the climate crisis. Two years ago, the author launched "Imagine 2200," a juried short story contest where people from diverse backgrounds shared hopeful stories around future climate change that received 1,100 entries from around the globe. "I had a momentary thought during the presentation," she explained. "While the author talked about the international energy around this type of writing, I thought we could bring this down to the local level." Both Progress Norwood and the library staff embraced the idea of collaborating on a digital book project where area residents could submit their projects on a more sustainable world through an optimistic lens.

"We want people to share their daydreams about what the world could look like," she continued. "This is a chance for people to stop worrying for a moment, take a deep breath, and show that we can get there. It's a way to comfort and reassure one another that we are not alone in this."

The talk she will lead at the library will discuss the relatively new genre that began in 2008. She will go into detail about solarpunk's genesis, the project, and how to go about creating and submitting a piece. There is a signup form for the discussion on the norwoodlibrary.com webpage, although registration is not necessary. Any questioned can be directed to Clare at sustain@tgryes.org.

There will be a follow-up meeting on March 13 for people interested in having Clare give guidance "on the skeletal submissions," and the final composition will be due by March 26 for proofWhile it recognizes the detrimental effects of global warming on the environment, it seeks to explore alternative realities through science fiction writing, paintings, drawings, textiles or sculpture. years if and only if the H. 4287 bill passed. The bill was initially referred to the House's Committee on Public Service on Dec. 13, 2021.

As previously reported in The Norwood Record, this bill had been stalled in the Senate Committee on Bills in the Third Reading since June 30, 2022. Consequently, it did not advance to the Senate floor or ultimately to the desk of then-Gov. Charlie Baker for his signature before the end of the legislative session on Jan. 3. By law, firefighters and police officers are required to retire when they turn 65 due to potential health issues associated with age and the job, but home rule petitions can circumvent that. One example is the age exemption for current Norwood Police Chief William Brooks that he received a few years ago with the support of Town Meeting, the Board of Selectmen and the department's two unions.

Rush and Rogers stated in the letter that they did not "fail" to pass the bill, as Norwood Selectmen Chair Bill Plasko had previously said, but "chose not to act on it." They stated this was due to apparent controversies around the bill, which included statements made in opposition to the warrant article by Norwood Firefighters Local 1631 President Paul Ronco and Dennis Mawn at the Special Town Meeting in Oct. 2021. At that meeting, they suggested that the timeframe of the waiver only be one or three years. Both of these motions were voted down, allowing the home rule petition request to advance to Rush and Rogers for bill sponsorship.

One of the most concerning accusations in the letter accused Plasko of being with three other Norwood selectmen attending a fundraiser for Senate President Karen Spilka on Nov. 9, 2022 to lobby for the bill, along with Hayes and Mazzucco. Having a majority of board members present at any activity where official business is discussed is a violation of the state's Open Meeting Law. At this fundraiser, Rush and Rogers alleged that \$100 was given by both Plasko and Mazzucco "to influence the outcome of legislation pending in the Senate," the letter claimed.

"Mazzucco and Plasko each handed out \$100.00 in the ill-advised attempt to inappropriately influence H. 4287 into state law," Rush and Rogers stated in the letter.

It is unclear at this time how the legislators knew about the alleged transactions. In an initial joint statement to The Norwood Record sent by Rogers on Jan. 13. it was alleged that "Mazzucco and Plasko each handed out \$100.00 in cash." A cash transaction would be difficult to trace. Selectmen Helen Abdallah Donohue. Bob Donnelly and Selectman Amanda Grow were contacted by The Norwood Record but did not respond to requests for comment. "Unfortunately, the only comment I can provide at this time is that the matter is being reviewed by the Board of Selectmen in order to provide an appropriate response," Selectman Matt Lane said an electronic message on Wed. Feb. 1.

of them attended.

The letter also claimed that Mazzucco "directed four (4) Members of the Norwood Board of Selectmen and the Norwood Fire Chief, with himself, to attend a political fundraiser with the intent of misusing the power of the Norwood Board to influence the outcome of legislation pending in the Senate."

It is unclear if and how the alleged directing of these officials could have been achieved by Mazzucco, if his direction indeed had occurred, or how these officials responded to the alleged request, if it had been made. Because responses were not received by The Norwood Record by any of the parties possibly involved, this allegation could not be substantiated independently.

According to the state, a single violation of Massachusetts' Open Meeting Law can carry a penalty of a fine "not more than \$1,000 for each intentional violation." (https://bit.ly/3JO5VWq)

Rush has never communicated directly with The Record since the newspaper began its reporting on the bill's future during the fall, although his and Rogers's offices released a joint statement on Oct. 4 attesting to their dedication to the people of Norwood and the legislation.

This statement was referred to as "baloney" by Plasko at a Board of Selectmen's meeting in early January when the bill failed to move forward.

As a follow-up, Rogers sent an email to The Norwood Record on Jan. 13 signed by both him and Rush that included much of what the letter to Town Meeting members stated. In this email he stated that "Plasko is lying." Some of the comments made in this letter were incorporated into a Jan. 19 article in The Norwood Record on the situation.

One issue that was not mentioned in the TMM letter is a statement that Hayes, Mazzucco and Plasko are currently being investigated by both the State Ethics Commission and the Attorney General's Office, at least according to a release from Rush and Rogers.

"Due to strict requirements for confidentiality placed on the State Ethics Commission by statute, I can neither confirm nor deny whether any complaint has been received or whether any matter is under review," wrote Gerry Tuotti, the State Ethics Commission's senior public information officer, in a Jan. 25 email.

The Attorney General's Office has not responded to The Norwood Record's request for information initiated on the same day.

The Norwood Record could not confirm some allegations for that article by spired with Chief Hayes to violate [Massachusetts General Law] Chapter 268A to use Norwood's public resources to illegally lobby for a bill solely benefitting Mr. Hayes, legislation that would have compensated him by more than \$700,000 over the extended term."

According to malegislature.gov, the law refers to "conduct of public officials and employees." The law's subsections pertain to state officials and people involved in judicial proceedings.

SD 823, a bill referenced in the Chapter 268A summary, was titled "An Act Clarifying Lobbying Law Violations." A search for the document on malegislature.gov only showed that the bill was filed by Sen. Michael D. Brady, a Democrat representing the Second Plymouth and Norfolk District. There was no text shown of the summary on the page.

In their letter, Rush and Rogers went on to state that Hayes used a phone issued by the Norwood Fire Department on May 24, 2022 at 3:23 p.m. to lobby for passage of the bill. This information could not be verified by The Norwood Record because department phone records could not be obtained. The letter stated that this alleged phone call violated his contract of employment.

"The call from May 24, 2022 is a <u>bla-</u> tant violation of Section 12 of <u>Hayes's municipal contract, dated</u> October 13, 2021, that he signed with Mazzucco, a contract that <u>Mazzucco attempted to conceal from</u> the public." (their emphasis).

The legislators also alleged that on two occasions - July 26 and Dec. 30, respectively – "Hayes instructed a Fire Department employee to use municipal servers, on municipal time, to lobby for the legislation that solely benefited himself." On another occasion on Aug. 26, Rush and Rogers wrote in their joint statement that "Hayes used municipal servers, on municipal time, to lobby for legislation that solely benefited himself."

It is unclear at this time how the legislators obtained the information published in their letter.

The Norwood Record reached out to the Town's Information Technology Department on Mon. Feb. 6 in an attempt to retrieve the electronic communications, but did not receive a response by press time.

Other accusations were alleged in the TMM letter from Rush and Rogers, most of which chastised Mazzucco for his alleged actions to lobby for the bill. One was that Spilka's office contacted him two weeks before the end of the legislative session. The letter stated that "the Senate President's office informed Antonio Mazzucco of the legislative decision to block the final vote for the remainder of the Session, thus rejecting the bill." In the TMM letter it specifically states, "Mazzucco chose to withhold this information from the People of Norwood regarding this call in an attempt to cover up his failures and unethical actions, and those of Selectman Plasko and Chief Hayes, on this matter." (their emphasis). The Norwood Record has not received responses from those mentioned regarding any allegations made against them by press time, as noted previously. Another issue was that of Hayes' contract, according to the letter. The contract allowed for Hayes to stay on another five years past his mandatory retirement date with a salary. This was explicitly made contingent on the passing of the home rule petition that would have allowed him to stay past age 65.

The contract was provided by Mazzucco to The Norwood Record via email on Oct. 4, 2022 and was discussed in an interview with the newspaper on Oct. 7. Information was subsequently included in the October 13, 2022 edition of The Norwood Record (https://bit.ly/ 40Bve3V). This article is referred to in the legislators' letter as to how they learned of the existence of the contract in the following statement:

"Mazzucco also never told us about the existence of this contract until a local newspaper obtained a copy of it a year later," the TMM letter stated. "For Mazzucco, it took more than a year before they contacted us."

A meeting to discuss the bill's future occurred on Nov. 17, 2022 at the State House among Rush, Rogers, Mazzucco, Donohue and Donnelly, which all parties agreed did occur.

The most blatant accusation made by the two legislators was that "[a]ll of the foregoing was illegally conducted at the direction of and under the supervision of Town Manager Mazzucco." It is unclear at this time how Mazzucco would have supervised this alleged activity by the unnamed selectmen.

The third section of the letter stated that "[o]n Nov. 9, 2022, our offices had to reiterate to Mazzucco, several times, of his repeated attempts to violate the Open Meeting Law." This was done by Mazzucco, they alleged, "by demanding a quorum – Plasko and two (2) other members of the Board of Selectmen – to attend a State House meeting with us, on November 17, 2022, to discuss and deliberate upon this legislation." Selectmen Donnelly and Donohue attended this meeting.

After consulting with Senate Counsel, the legislators said they phoned Mazzucco. They said that a quorum would constitute an Open Meeting Law violation. Rush and Rogers also said that Hayes would have to take personal time off to attend the meeting to lobby them on his own behalf. It is unclear if Hayes did take a personal day.

Another allegation the legislators made in the letter against Mazzucco is that he failed to let their offices and TMMs know of the existence of Hayes's contract that was signed five days before Town Meeting voted on the article. The contract stated that Hayes would "keep his job until the age of 68 at the same time he was asking Town Meeting to keep him on the job until age 70."

A chronology of the actions pertaining to the bill that encompassed about two-and-a-half pages was provided by Rush and Rogers in the letter.

The letter ended by noting that three other home rule petitions passed the Legislature that they sponsored "at the request of Norwood Town Meeting." By contrast two out of five of Dedham's requests were signed into law, they stated. They also said that home rule petitions are not automatically approved by the Legislature. "Of all the bills we filed for Norwood last term, H. 4287 was tainted by the actions of Mazzucco, Plasko, and Hayes, and remains the only one the Legislature refused to enact," (their emphasis), they wrote. "As your state legislative counterparts, we remain committed to you in partnership of behalf of the People of Norwood, whom we mutually serve," the letter concluded. Questions about the situation remain lingering with Norwood residents. Until responses from the parties involved are received, or a statement is issued at the Feb. 14 Board of Selectmen meeting, apparently they will remain unanswered. If the matters are indeed under investigation, then the officials can refrain from comment, but this has not yet been corroborated by anyone involved.

It is unclear who the other selectmen accused of being in attendance at the Spilka fundraiser were or if in fact any press time because it was sent by Rogers at 4:59 p.m. on the Friday evening before the holiday weekend honoring Dr. Martin Luther King Jr. Efforts were made over the weekend to contact those mentioned in the accusations. Interviews were conducted with Ronco, Mawn and Donohue by The Norwood Record on Sat. Jan. 14, while two emails were received by Plasko on Sun. Jan. 15 in response to the allegations and reported on in the Jan 19 issue of the newspaper. Mazzucco was out of town during that time period and could not be reached for comment.

Another disturbing accusation made by the legislators was that "both Mazzucco and Selectman Plasko con-

OPINION Where did the detail come from?

Where did the detail come from?

As most are aware, a war has erupted between Town officials, Norwood's elected legislators and the Norwood Fire Department's union leadership. Historically, this Town's Board of Selectmen has had a rocky relationship with the NFD but it had never gotten to the point of name calling and conspiracy and ethics violation claims to a degree to which it's at now.

The latest salvo in this somewhat pathetic battle was a bomb thrown by both State Representative John Rogers and State Senator Mike Rush in the form of a joint letter to Town Meeting members explaining why the Senate Committee on Bills in the Third Reading "chose not to act on this legislation" as opposed to the wording used by Town officials that the bill "failed to pass." The letter then goes on, in great detail as to the importance of this distinction, which many will construe as their just trying to cover their own derrieres. There is plenty of blame to go around, the end result still being that EVERY-ONE involved in this fiasco failed to achieve an extension of Chief David Hayes' tenure as Norwood Fire Chief.

It has been stated by Town officials that the genesis of this failure was union leadership's meddling in affairs they shouldn't have been involved in, most notably that at least one member called on his friendship with Rogers to put the kibosh on Hayes' extension. This newspaper actually wrote an Opinion column supporting the theory that the union was pulling its usual power play of sticking its nose in, not because it should but just because it could and that this has always been the root of its dysfunction. Union leadership has vociferously denied any involvement in trying to derail Hayes' contract. Unfortunately, after reading the recent diatribe submitted by Rogers and Rush we believe more strongly than ever that union leadership isn't being truthful.

The letter does raise a couple of salient points regarding Town officials' actions taken in this mess, most notably by Town Manager Tony Mazzucco and Selectmen Chairman Bill Plasko, but most of it is what we used to refer to in the old neighborhood as "mouse nuts," just inconsequential points meant to distract TM members from the fact that their wish was ignored. And if that doesn't anger TM then what is the point of their showing up at meetings at all if the powers that be are just going to do what they want to do anyway? And any argument used that TM's vote was problematic because of low attendance or the closeness of the vote is an insult to democracy. Any majority, even as small as one vote, represents the will of the people. The fact that Rush and Rogers even mentioned this is insulting.

As mentioned above, this newspaper believes now more than ever that the NFD union was consequentially involved in foiling Hayes' tenure and here's specifically why. The article on Page 1 provides a thorough summary of the letter, and a full copy is available on our website https://norwoodrecord.weebly.com. It is crucial to pay attention to the points both Rogers and Rush make relative to improprieties by Town officials and Chief Hayes himself, particularly #2 IL-LEGAL USE OF MUNICIPAL RESOURCES. The letter goes into great detail as to how Chief Hayes used Town resources to improperly lobby for his job, providing very specific dates and times as to when Hayes was on the NFD phones lobbying and using municipal servers on his own behalf, etc. Our question is how do Rogers and Rush know this? How do two representatives at the state level have such specific knowledge of internal NFD activities? This information is not only proprietary, it's most assuredly password protected and available to only a very select few. Unless someone provides us with a reasonable explanation, we can only continue to believe that the union, Rush and Rogers worked in unison to derail Chief Hayes. Everything else is just superfluous mouse nuts.

Morse committee considers repairs, historic designation

The Norwood Morse House Subcommittee met at the Norwood Town Hall on Monday and discussed two prominent issues facing the building: the Community Preservation Committee (CPC) funding application and the building's windows.

The Committee discussed the recent approval granted by the CPC to allow the Morse House to apply for CPC funding for repairs. The Committee outlined that the focus of the first phase of repairs is to stabilize the structure. These repairs include the foundation, windows and the replacement of tree stumps currently used in the basement as supports.

The CPC voted unanimously to allow the Morse House to apply even though it's currently passed the CPC's regular deadlines for submission for the next fiscal year. The CPC needs to have its submissions in order, then a public meeting to discuss them and finally approval from the Board of Selectmen in order to get the project on the CPC's submission list for the Annual Town Meeting Warrant Opinion in the spring. Continued on page 10 The holdup currently is that

the Norwood Facilities Department has not yet compiled the estimates for the needed work. Norwood General Manager Tony Mazzucco said they should have the estimates in hand by next week.

"I'm pushing Facilities right now, we're working on it," he said. "They're busy, as they always are and are trying to get it done. Our buildings largely survived this weekend (subzero temperatures), but we have a couple small repairs and a never-ending workload so we're just trying to balance it."

There was some question as to whether the committee could bring an application to the CPC and have it ready before the upcoming May Annual Town Meeting, or perhaps get it in for one of the later special town meetings in the fall.

"I'd like to get at least something before Town Meeting in May, even if it's just the foundation work," he said.

The windows were a hot topic because of a discussion the group had with Historic Preservation Consultant Jeffrey Gonyeau. Gonyeau said that if the Town is looking to receive a designation from the National Historic Registry or the local Massachusetts Historic Registry, even seemingly minor repairs can hurt an application. He said the Town should keep this in mind when considering its window repairs.

"There's nothing that diminishes a building's historic value more than to suddenly have bright white replacement vinyl windows in openings where there were once complex flashes or authentic divided lights etc.," he said.

He recommended that they

from substance use disorder sprays. Bernadette said they for so many years; we were so used to trying to save him, get him the right treatment, continue treatment, bring him home to live with us. It's just a terrible disease," she said. "Losing Ricky was more unbelievable than we could have imagined. We started this because we couldn't just stop doing what we did do for him for so many years."

Bernadette said it's important to remember that whatever someone has gone through, whatever has driven them to where they are; their illnesses, homelessness or substance use disorder is not the entirety of who they are. They said they knew that their son was a complete human being and not just an opiate user.

"Ricky Inc. is a nonprofit and our goal is to help people who are experiencing homelessness, substance use disorder and mental health concerns, and the same goes for them; it doesn't define who they are. They are just so much more than that to their family and friends."

The pair said they were happy to receive permission from the state – after going through a lengthy process distribute NARCAN to

felt good about it because they knew from experience that it saved lives.

"It saved his life multiple times, and so we fought very hard; it seemed daunting at times, but we finally talked to the right person at Access, Harm Reduction, Overdose Prevent and Education (AHOPE) in Boston, which also is a place we distribute backpacks to. We were finally approved to distribute it and also approved as a nonprofit to receive it at no cost."

She said that was Ricky's passion, to save people's lives. She said they are very proud to be able to go down to hotspots and treatment centers, detox facilities and recovery homes and give out NARCAN and train anybody in its use.

Richard said they pack the backpacks with razors, deodorant, toothpaste, toothbrushes, shaving cream, antibacterial wipes, condoms, band aids, Blistex, face masks and, in the winter time, winter hats, gloves, garters, and a fleece blankets.

"We also include a resource manual that we put together," he said. "It's a folder that has hundreds of phone numbers and names of contacts, shelters, detox, rehabs and more. If someone's on the street and they're in crisis, somebody is going to be available to help them."

The Giacoppo's are hosting a fundraiser at the Norwood Theater on March 30 with comedians Steve Sweeney, Lenny Clarke and Jimmy Tingle. All are Boston comedy legends - with Sweeney rumored to have come up with the idea for the sitcom 'Cheers'.

Richard remembers Tingle and Clarke as neighborhood friends.

"He grew up going to high school with Lenny and Jimmy," Bernadette said. "They played sports together and they've been friends for years."

Both Tingle and Clarke have spoken openly about their struggles with addiction, and Richard said they got Sweeney in as a favor to them. Sweeney himself works in the field of substance abuse for two or three days a week going to places like the Plymouth County Correctional Facility to counsel and teach. He's also been an advocate for homelessness causes and other issues around poverty.

Both Richard and Bernadette said they interacting with those suffering from addiction, experiencing homelessness or in a mental health situation, the simple act of caring is extremely powerful.

possible and install storm windows over them.

The inclusion of the Morse House on both historic registries would open the door for future grant funding, so the committee discussed the issue at length.

Mazzucco said the Town has a bit of experience in historic windows and that gives him a bit of pause.

"We redid the Town Hall windows in 2002, and they did

repair the windows as best as look somewhat attractive from the outside, but they are a disaster," he said. "They're horrible; they fall out, they don't last, they have a terrible mechanism. I mean we spent a lot of money (\$650,000) and we got a terrible product."

> Mazzucco said there are much better and more cost-effective methods of maintaining a look rather than having to go in for a full historic renovation.

"These (Town Hall win-

The Norwood Record dows) were manufactured in England to be period-specific

because we always want the building to look beautiful," he said. "However, I think we could have gotten a better product if they were more modern and trying to match the look. Instead we've got crappy windows. Half the windows you have to jam paper in the latch to keep them closed. The windows themselves aren't really poor quality, it's just that there's a reason nobody builds them that way anymore."






