# Hospital misses deadline to deal with water runoff Progress possibly slows

The Norwood Planning Board met on July 11 in a hybrid format and Town Planner Paul Halkiotis gave an update on the current status of the plan to rebuild Norwood Hospital.

The prognosis? Slow, to say the least.

At the last Planning Board meeting in June, (https://bit.ly/3aqTJvL), Halkiotis and hospital representatives went back and forth regarding the hospital's drainage plan. In a nutshell, Halkiotis and the

Town's consultant engineer from Tetra Tech Matthew Moyen agreed that while the drainage plan presented would take all the water off the property, the pipes connected to the hospital were not large enough to accommodate large storms and heavy flooding.

A June 28, 2020 downpour resulted in the hospital's basement being flooded requiring closing the hospital, as it turned out, permanently. The basement housing the complex's HVAC which, along with several other factors, directed water essentially

throughout the whole series of buildings. Now, Halkiotis said there is an issue as to what the Planning Board would be able to approve considering any plan the hospital puts forward would probably require approval from other government boards, not to mention Town Meeting.

To address this, the Board and hospital representatives agreed to a special meeting on July 18 to figure out a plan moving forward. Halkiotis said there were requirements to meet before the meeting

# ConCom updates on Alevizos, paw paws and Pezwick

The Norwood Conservation Commission (ConCom) met on July 6 in a virtual format and discussed several items.

First, Town Conservation Agent and Environmental Planner Holly Jones gave an update on what's going on at the Town Orchard near the Coakley Middle School on Mylod Street. She said ramps are currently under construction, and she has an intern currently working on watering and weeding the orchard.

"And hopefully following up on (ConCom Chair Stephen) Washburn's dream of documenting the orchard and keeping track of how things are growing and what we're doing there," she said.

Washburn said that was good news and would equip the department with digital survey software to help. "I'm waiting to try a paw paw," said ConCom member John Gear.

"Likewise," said Washburn. "But what are we going to do? Is it something you make a pie with? A juice? I'm very curious."

"I've only ever eaten one paw paw fruit and I ate with a spoon," Jones said. "It has a pudding-like texture."

"Well I'm excited for that too," said Washburn.

The longest discussion arose over a concern of resident and Town Meeting

# Disney's Nor-Hollywood bid on hold

Norwood Town Manager Tony Mazzucco stated in a press release this week that the filming of a Disney Halloween-themed movie has been "suspended" until further notice.

The movie was to film for about a month on the Town Common, the Norwood Theater and several nearby residential locations. The Board of Selectmen said during its June 28 meeting that the Town would be happy to accommodate the production, even if it meant moving some events around.

Mazzucco said "We are saddened to inform the community that the Disney Halloween-themed movie has been delayed and will not film in town next month as planned," he said in a statement. "We were looking forward to welcoming the production team to Norwood and for audiences across the world to be able to see all our town has to offer through this film."

Dragon Force Productions representative Kyle "Snappy" Oliver said during his pitch to the Board of Selectmen a couple of weeks ago that they wanted to turn Norwood into a second Salem, a kind of Halloween hot spot, if the film did well enough.

"I think one of the very exciting propositions is that we would actually like to have our town in the movie be the Town of Norwood," he said. "We would film in this town as the Town of Norwood. The only problem with that is we might start an urban legend for all of you where, come Halloween, people will be coming here expecting that Norwood is the Town for Halloween. Hopefully you will be okay with that. Maybe you'll get a little rivalry going with Salem."

Mazzucco said they were happy that Norwood was in the running for the movie.

"We are grateful to the production company for its consideration of Norwood and recognition of the many historic and quaint aspects that make our town an ideal filming location," he said.

Norwood has a storied film and television history these days, starting with a small role in the beginning of Ted (during a voice over of Sir Patrick Stewart), and Mazzucco said he doesn't feel this will be the last audition the Town has moving forward.

"We hope that similar opportunities to showcase Norwood will present themselves in the future," he said.

member Toni Eosco regarding the Alevizos Park, near Endicott Street and Route 1A, also known as the Lower Pond Pavilion. Eosco expressed worry over three reasons: climbing, yoga and parking.

First off, Eosco said she's talked to the youngsters climbing on the pavilion and they've agreed to stop. She said while she was impressed with their abilities, it was dangerous and not the intended use of the property. She said however, the youngsters brought up a good point.

"It was like watching Cirque de Soleil over there, but it was a little disconcerting as well," she said. "I was able to talk to these young people. I think they're listening or finding somewhere else to climb. I do feel that their comments that there was not sufficient equipment for the tween groups, you know, 10, 11 and 12, was kind of valid and I said I'd mention it to the higher ups. But in the meantime, we need to keep the pavilion safe."

ConCom Chair Stephen Washburn said they are looking into posting signs to dictate land use. Jones said they already have such signs at Ellis Pond.

"And I think it could make sense to do the same here," she said. "We do have some standard land use regulations that I could re-share with commissioners to make sure they make sense. I know we don't have climbing regulations, which might be one we want to add."

The other two issues, yoga and parking, are somewhat related. Eosco said there is a group arriving at around 6:30 a.m. to hold yoga classes. The ConCom membership noted that the participants are not taking formal classes and the effort is paid for strictly by donations, and so even though it is public conservation land, there would be little they could do to stop it. Eosco said she's very positive about the yoga itself, it's just the timing. She said the nearby Applied Plastics company starts very early, but only on weekdays.

"So Saturday is a day when we don't have to hear car doors slamming at 6:30 a.m., and now I have a yoga class," she said. "I just thought that was a little early.

"The project is not really complete without the six parking spaces," Eosco said. "When cars are parked on both sides of (Endicott Street), it's a single lane, and this is a busy street intermittently, especially when the antique shops are open."

Jones said the parking was originally pitched as part of the application, but was taken out due to another entity being assigned the responsibility to construct those six parallel spots originally proposed.

"The developer of Endicott Woods, the development at the end of the street, has committed to repave Endicott Street," she said. "They have been held up by the Massachusetts Department of Transportation because of an issue concerning where Endicott connects to Walpole Street or State Route 1A. So there's a little bit of 'hurry up and wait' for the developer to get the permit from the state."

Also during the meeting, the Commission voted favorably to two of the three proposals on the agenda for the night. First was a unanimous vote to allow the proposed expansion of a parking lot at 505-537 University Ave. for Metropolitan Cabinets and Countertop. The second was a favorable unanimous vote for Addie's Grocery at 911 Boston Providence Hwy. that would relocate the drainage system and install three new catch basins near the riverfront area of Meadow Brook.

The Commission voted to continue a hearing from the Massachusetts Water Resource Aurthority (MWRA) for the construction of an access road off the shoulder of Neponset Street and the improvement of an access road behind 290 Vanderbilt Ave.

# Selectmen oppose proposed new open meeting requirements

The Board of Selectmen met on July 12 and discussed a new bill being considered in the Massachusetts State Legislature regarding remote access during open meetings.

Town Counsel Karis North was before the Board to discuss the implications of Section 17A-J of House Bill 4991, which would, if passed, create new regulations regarding remote participation in public government meetings, the most significant change being that all government bodies would have to provide remote participation access as a matter of course.

North said the current regulations allowing remote participation as a matter of right are sun setting on July 14 and would revert to the old legislation, which requires approval from the executive governing body (in this case the Board of Selectmen) to allow remote participation.

According to North, "What originally happened is the Senate tried to pass a clean extension, and then the House made some revisions and it's gone back and forth," she said. "Earlier this week, I think on the 11th, the House enacted, by voice vote only and not by roll call, some amendments to the Open Meeting Law Extension that could raise significant concerns to cities and towns throughout the Commonwealth."

North said along with the remote participation access requirement for every public body, it would require that access be provided through video or internet and not by phone.

"It's a little unclear to me from the legislation but the access has to be through internet, video or other video technology, it would no longer allow phone access, which is a significant to anybody who doesn't use the internet, isn't comfortable with the internet or can't get good internet service, which is more of an issue out in Western Massachusetts," she said. "You would no longer be able to call in with your cell phone to participate in the meeting."

North said meetings would not be completely remote, as at least three members of the public board would have to be present. She also said that once minutes are approved by a board, they have to be posted to the municipality's web site within 10 days, which could be a strain on the Town Clerk or whoever is responsible for posting minutes and updating the municipality's web site.

Lastly, she said the bill would add a civil fine for individual members of the public body for any third unintentional violation of the Open Meeting Law.

"I know you all know how difficult it is to get people willing to serve on public bodies, and this might just further deter people from getting involved in local government," she said. North recommended that the Board send a letter to State Rep. John Rogers and State Sen. Michael Rush to let them know their opposition to this change.

"The state would be telling us to do this without allowing us to figure out what we can do and how much it will cost," said Selectman Bob Donnelly. "Things like this, unfunded mandates, come in when the state is running a surplus and they're providing rebate checks to residents and come before us and tell us that you, the municipality, need to not only employ this technology but come up with the money to do it. I think the cleanest thing would be an extension of the current status until such time a new session starts."

The Board generally agreed, and though some felt the idea had some merits, 'kernels of good ideas,' as Selectman Matt Lane put it, they felt it was too overreaching, rushed and too broad to be able to work.

"There are articles I've read and I'm sure others have too of how remote meetings have provided people who might not normally participate a way to, which I think is great, but these things do come at a cost," he said.

The Board voted to delegate the letter writing to Selectman Amanda Grow and Assistant Town Manager Michael Rosen

# Registry Real Estate Activity Report

Norfolk County Register of Deeds William P. O'Donnell reported that second quarter (April-June 2022) Norfolk County real estate statistics shows a continued uptick in residential and commercial sales and sale prices, despite overall numbers trending downward.

Register O'Donnell noted, "During the recently concluded second quarter of the 2022 calendar year, the average Norfolk County real estate sales price, both residential and commercial, increased 30% to \$1,300,157. Total real estate volume, again both residential and commercial, was \$4.09 billion, a 16% increase year over the same period in 2022."

Register O'Donnell further stated, "The lack of inventory and new construction continue to push prices up. It remains to be seen if this trend continues as overall activity is slowing considerably."

For the second quarter of 2022, the number of land documents recorded, (such as deeds, mortgages, homesteads, mortgage discharges, etc.) was 35,744, a 31% decline from the second quarter of 2021. Register O'Donnell noted, "This figure tells us while there is still a healthy real estate market, market conditions and rising interest rates are starting to have an impact. We are not seeing the volume we saw in 2020 and 2021."

There were 6,809 mortgages recorded at the Registry during the second quarter of the calendar year 2022 compared to 12,041 for the same time period in 2021, a 43% decrease. Total mortgage borrowing was \$5.06 billion for April through June compared to \$6.63 billion during the same period in 2021. "With the increase in interest rates, consumers seem to be less inclined to borrow", noted the Register.

Norfolk County homeowners continued to benefit from the Homestead Act. A total of 3,315 declarations of homestead were recorded during the second quarter of the calendar year, a 10% decrease over the same period a year ago. "The Homestead law provides limited protection against the forced sale of an individual's primary residence to satisfy unsecured debt up to \$500,000. I urge Norfolk County residents to consider this important consumer protection tool," noted O'Donnell.

A sharp increase in foreclosure activity in Norfolk County remains a cause for concern. Sixteen foreclosure deeds were recorded in the second quarter, the same number recorded during the second quarter of 2021. However, there was a significant increase in the number of recorded Notices to Foreclose, the first step in the foreclosure process. There were 66 Notices recorded in the second quarter versus 33 recorded in the same period of 2021.

O'Donnell stated, "While the eastern Massachusetts economy remains on a solid footing, there are still those in Norfolk County experiencing economic hardship, in many cases through no fault of their own. The Registry continues to work with Quincy Community Action Programs, (617-479-8181 x376), and NeighborWorks Housing Solutions, (508-587-0950) to help homeowners who may have received a Notice to Foreclose document. A third option is to contact the Massachusetts Attorney General's Consumer Advocacy and Response Division (CARD) at 617-727-8400."

Register O'Donnell concluded, "The economy, particularly the employment numbers in eastern Massachusetts, appears to be strong but, going forward, inflation, rising interest rates and the lack of inventory will likely result in a slowdown of the Norfolk County real estate market."

# Firefighters pedaling to save lives in Pan-Mass Challenge

The Pan-Mass Challenge (PMC) is a bike-a-thon that, according to its own documents, raises more money for charity than any other single athletic fundraiser in the country.

Every first weekend in August (Aug. 6 and 7 2022) thousands of riders gear up to cycle

the length of Massachusetts, starting to the west at Sturbridge and heading into Provincetown on Cape Cod. The charity has raised more than \$831 million since it started in 1980, mostly raising funds for Dana-Farber and the Jimmy Fund.

Norwood Firefighter and Medic Paul Ronco is part of the Norwood Fire Department (NFD) team riding this year. He, Firefighter Elizabeth Cabral and Firefighter Joe Mawn are all riding 192 miles to raise money for cancer.

Ronco said this ride has a special significance because cancer is one of the leading causes of death among firefighters. Ronco said this is especially hard hitting for the NFD, as they just recently lost

John Bellanti to multiple melanoma last year.

"I think that really affected a lot of guys here at the station and neighboring fire departments, losing him at such a young age was a tough pill to swallow," he said of Bellanti, who died at age 60. "IOn top of the loss of Bellanti, another member of the force has been diagnosed with cancer. He's in remission, but cancer is really hitting the fire service hard. However, it has led to a good thing. "We are getting cancer screening ultrasounds provided by the Town every two years. We actually negotiated that into our contract."

Cancer is on the minds of all firefighters, especially after it was discovered that parts of the standard-issue gear provided to the departments all contained polyfluoroalkyl substances (PFAS). These substances have been linked to higher rates of cancer according to the International Agency for Research on Cancer and many other organizations. Ronco said they are following the local lawsuits concerning the suits and the flame retardant foam they use, which also contains PFAS.

"The International Association of Firefighters and the Professional Firefighters of Massachusetts unions are really pushing hard to make changes to our turnout gear and getting PFAS out of those and our firefighting foam," he said. "It's really an issue to work smarter and be safer."

Ronco said the PMC is not an easy ride to make to say the least. "I'm not a biker," he said flatly. "It's physically definitely a challenge."

"It's called a challenge for a reason," Mawn interjected.

"But riding through all these cities and towns throughout the whole route and having hundreds of people standing by the wayside with no idea who we are but all there cheering you on, it's really inspiring," said Mawn. "What really hits me the most is during the last couple miles of the first day, they have all the pictures of the kids who survived because of the donations to Dana-Farber. You don't even realize your pedaling at that point, it's just amazing."

Cabral said she has done four full rides before this one and had volunteered at the race before that

"I got involved for several reasons, but firstly because I'm an emergency room nurse and I cannot get through a shift without taking care of someone affected by cancer," she said. "I first volunteered and then was so inspired I decided to ride the next year. I just feel like we should do anything we

can and I love the Pan-Mass because every dollar raised goes directly to Dana-Farber."

Cabral said she lost her mother-in-law last year to cancer, and she was treated by Dana-Farber.

"I think they're an incredible organization and the Pan-Mass gives millions to Dana-Farber every year," she said.

"The goal this year is \$66 million," Mawn said.

"And that motivates us. It pushes us to do everything we can to raise money for this incredible organization," Cabral said

Cabral and Mawn both said the ride is fun and challenging at the same time.

"You'd think the Cape is flat but it's not," she said with a laugh. "But the crowds get you there. Literally going from Sturbridge to Provincetown, the roads are lined with supporters. When you see the signs that say, 'My heart because of your feet,' you keep pedaling."

Mawn said he's done the PMC for 12 years and said the training for the event is extensive.

"It's a 10-week program where you progress in mileage," he said. "We practice around here, around Route 109 in Dover and Sherborn. And as you go on the weekends you see a lot of other PMC riders preparing for the challenge."

Mawn said the ride has brought himself and the other Norwood Firefighters into a wider community.

"I would have thought there were 10,000 volunteers, it's so well-run and such a great community," he said.

# Limey's Tourney raises \$11,500

Norwood's Limey's Tavern raised \$11,500 for veterans at this year's Limey's Veterans Golf Outing.

Co-owner A.J. Jeannetti said they have done this now for about seven years for veterans. "We started it about nine years ago for a different cause but vets had become such a big thing for us we ended up switching it over."

Jeannetti said they have a very regular crew of golfers who sign up. He said while they do get new teams signing up occasionally, the returning crews make it a mainstay event for the organization.

"This year we had about 142 golfers," he said. "It was our biggest turnout of golfers yet. Year after year people take the day off from work. They plan for it every year. There are some new teams, but for the most part it's the people who have been playing almost all seven years."

Jeannetti said some of the teams take the competition very seriously.

"The winner was -17 (17 under par), and second place was a little off at -12. The winners were a really serious team this year. I think they had four T1 golfers. Then it was -11, -10. Others just show up to have a good time and support the cause."

Jeannetti said they recently teamed up with Boston Executive Helicopters at the Norwood Memorial Airport to do a helicopter golf ball drop for charity. Basically, you buy a golf ball and the one that lands closest to a designated spot, in this case the 18th green at the Norwood Country Club, wins.

"They donated the helicopter and flew it over, folks paid \$20 a ball and I numbered 250 balls," he said. "It was great to see them supporting us and bringing more money to the cause."

Jeannetti said they take \$3,000 off the top and give it to Vet to Vet, an organization out of Brockton, and the rest go to Norwood Veterans Services, "Which was \$8,181 this year actually," he said.

Norwood Veterans Agent

Ted Mulvehill said the tournament brings in some much needed funds for the Town's veterans.

"First of all, we owe Limey's an incredible debt of gratitude," Mulvehill said. "They have been so supportive of our programs for the last several years and they continue to amaze us with generosity and compassion for those less fortunate in the veteran community."

Mulvehill said the money the tournament raised for Norwood Veterans Services is designated for the William P. Kazulis Christmas Fund, established for a U.S. Navy Sailor killed in World War II.

"He was in the back end of a fighter bomber during a bombing run and, unfortunately, flak entered the aircraft and killed him," he said. "Billy Kazulis was only 18 years old. We created a memorial corner to honor his memory at Lewis Avenue and Washington Street, where the family presented me with a check for \$100."



could take place.

"The meeting was scheduled with the understanding that they would provide us with revised plans and documents to review one week prior, and that deadline was Friday of last week, and today was the hard deadline to submit additional information," he said. "We did get an electronic submission of the plans this afternoon, and we were told hard copies of the plans would arrive later today. We did not receive those, and we also did not receive the stormwater calculations that go with the plans. There are some things that I understand the applicant's engineers want to discuss with (Town Engineer) Mark Ryan and Matt Moyen, but as of end of business today, that deadline passed, we received plans electronically and no hard copies and we did not receive the stormwater calculations."

Planning Board Chair Ernie Paciorkowski said he didn't relish having a meeting to just get a status update when the Board was not able to fully review information they would need to make any kind of decision on the stormwater issue.

"To be honest with you, I don't want to have another meeting with the hospital unless we're ready," he said.

Halkiotis asked that the Board hold off on canceling the meeting just yet, as he felt there was a good chance more information would come later in the week.

"I want to be at the point where we close the public hearing with at least some of these questions we're confident we got answers to," Paciorkowski said. "That's only fair; I don't want the Board to come in on an offnight just to hear, 'We're working on it.' It's really in their court now. They want us to rush through the hospital, but get us the stuff!"

Halkiotis said there are other issues to consider as well. He said there will be extensive roadwork for new proposed crosswalks and bump outs around the hospital, and Ryan had asked the hospital to pay for a complete repaving of Washington Street. He said the hospital has not agreed to that yet, and he added that for much of the large work items that the Town would have to pay for to accommodate the hospital's construction, they don't even have proper estimates yet.

"We have some infrastructure that is going to be impacted by this project, Townowned infrastructure, and at this point in time we haven't had a discussion with the Town Manager or the Board of Selectmen as to whether the Town is willing to foot the bill on some of those costs," he said. "But I think we need to do that. So we're in the process of trying to identify what the costs are for that work,

and once we know how much these big ticket items cost, we can have a discussion on who should be responsible for doing it."

The Board did not make a decision on canceling the July 18 meeting and agreed they would decide a few days later. The idea of pushing the meeting back one or two weeks was also floated, which the Board appeared to be more amenable to, but nothing condecided. crete was Paciorkowski emphasized that they were not trying to hold up the new building, but they wanted it done right.

"We'll do whatever we can as a Board to accommodate the hospital, but they have to come to the table too," he said. "We tell them, we'll help you, but I think it's unfair for the Town to whitewash this thing. We've got a 24-inch pipe going into a 12-inch pipe. I just don't think it's fair to the Town."

fused the money at first.

"I said, 'No no no, there's no donation needed for this, this is the Town honoring your family for your sacrifice, you're not supposed to pay anything for that," he said. "She told me to give it to the kids. Then a light bulb went off in my head and I said, 'I will.' And so I established the fund, and every year we utilize some of the money Limey's has given us to buy gifts and clothing to the families of veterans who are in need and are low income and don't have the wherewithal to make Christmas the special day it should be."

Mulvehill said they buy to get long-lasting toys, like bikes and outdoor equipment, to make as much of an impact as possible in the kids' lives. He said the Limey donation also goes to the Military Families Support Group, founded in 2001 after September 11.

"It was after we started sending reservists from Norwood to Afghanistan," he said. "We had 35 families affected by that call to active duty and they really were unprepared for something like that in terms of resources and education. Usually guys back in those days, prior to 9/11, they joined for an extra paycheck for one weekend a month of activity and two weeks of summer and other than that you go along with your regular civilian life."

Mulvehill said for some, that was quite a shock.

"We created the group to offer support in any shape, manner or form, be it financial, emotional, medical, any kind of support," he said. "We did stuff like plow driveways, mow lawns, electrical work, gas and oil; all that stuff. We also had specialists come in once a month along with therapists from the VA, all thanks to the generosity of Limey's patrons and the supporters of their golf program. It's just a wonderful, wonderful contribution to the veterans' community, very much appreciated by the families involved."

to ask for a direct extension of current regulations.. Grow said she would reach out directly by a phone call as well to drive the point home.

Also discussed during the meeting was the state of the plan to rebuild the Coakley Middle School. Lane, who also serves on the Middle School Building Committee (MSBC), said the committee is looking to cut costs since more recent estimates have come back higher than the budget override Town Meeting voted on had projected.

"But I think in the end we'll have a great building," he said,

adding that he and Donnelly, who also serves on the MSBC, will expound on those costs in a future meeting.

"What we are experiencing in terms of value engineering (cost cutting) is common to all building projects going forward currently, in Westwood, Walpole, they're all doing the same thing, and this is primarily due to the rise in costs of modern construction," Donnelly said. "It's not unusual and it was anticipated we would have to do some."

Lane said that the schedule to get the school built has not been affected.

"We received eight state-

ments of qualifications from firms interested in the project and we narrowed that list down to five we think have the expertise and have done similar projects," he said. "We're scheduled to interview those firms the first week of August."

The Board also voted not to impose further suspensions of the liquor license held by the Workman's Hall due to serving nonmembers. The Board agreed that the Hall acquiesced to its requirements and would not need another suspension to drive the point home.
